On behalf of the Trustees, it is my pleasure to present the 2022 Annual Report for the St David's Marist Foundation to you. This report covers the financial year ended 31 December 2022 and includes extracts from the audited Annual Financial Statements.

As with every year, I begin this report with a reminder of the main object and purpose of the Foundation.

The main object of the Foundation is to receive donations from third parties for the purpose of furthering the education objectives at and development of St David's Marist School, which as of January 2023 is now proudly situated at campuses in both Inanda, Sandton and Alexandra township, and includes the provision of support services, the promotion of the common interests as well as the transformation of the School. Central to the main object is ensuring that we give young men from previously disadvantaged backgrounds access to the excellence of a St David's education, grounded in its uniquely Marist philosophy and ethos.

As Trustees, we are deeply aware of our responsibility to manage the funds entrusted to us by our donors in a judicious and prudent manner in line with their wishes. The Foundation looks to balance the commitment to sustainably grow and support the number of young men supported with bursaries with growing the capital base available. Our goal remains to realise annual capital growth in excess of inflation, with a view to making annual



awards from the Foundation of between 4% - 6% of the opening capital balance. This is supplemented with donor-specific bursary funding which goes directly to the bursary costs of the identified recipients each year.

Through the Foundation's investments in the Centaur BCI Flexible Fund (Centaur Fund) and the Momentum Flexible Investment Fund (Momentum Fund) the underlying asset allocation comprises a diversified spread of South African listed and offshore equities, preference shares, cash, bonds and property. Approximately 60% of the Foundation's funds are invested in the Centaur Fund, 30% in the Momentum Fund and the balance in interest-bearing money market deposits.



### The year under review

The work of the Foundation has never been more important - increasing access to a quality Marist education and growing an alumni of future leaders able to tackle the challenges of tomorrow.

During 2022, St David's embarked on the ambitious task of developing a new satellite campus in Alexandra township, with the first enrolment in January 2023. This initiative is viewed as core to the future role that St David's believes it must play in advancing the education interests in the country.

Through the generosity of our donors, the Foundation made its largest annual award to date to the School during the 2022 financial year. In a year when the financial circumstances of many in our donor and wider community was under pressure, this was a remarkable achievement.

# *In reviewing the Foundation's activities in 2022 the following is worth mentioning:*

- 23 young men were supported on bursaries (2021: 22). Of these, nine included the costs of boarding at St David's.
- The Foundation's fund-raising efforts raised a total of R4 360 965 (2021: R2 634 782). This total includes donorspecific awards of R1 837 274. The Foundation's cumulative efforts over the sixteen-year period since founding have resulted in donations of R32 662 358 (2021: R28 418 702);
- Awards paid to the School amounted to R4 456 226 (2021: R3 280 692).
  Excluding donor-specific awards, the award made by the Foundation, including an additional R557 435 in operational business development allocation, comprised 6.84% (2021: 4.6%) of the Foundation's opening capital balance at the beginning of 2022.

This takes the cumulative awards paid to the School over the sixteen-year period since founding to R26.2 million (2021: R21.7 million);

- The Foundation's capital, after expenses and awards to the School, decreased by 5.02% to R34 929 583 (2021: R36 778 540) as at 31 December 2022; and
- Six of the Foundation-funded bursary scholars matriculated at the end of 2022, achieving excellent matric results.





The Foundation's operational expenditure budget for 2022 amounted to R557 435, which was utilised in support of fund-raising development and related initiatives. The School continues to cover the *majority of the operational expenses* of the Foundation office, however, from 2022 the Foundation began *contributing towards the salary* of a new second position for the Foundation, that of Foundation Office Manager. It nevertheless remains our objective that 100% of donor funding goes to the purpose for which it is intended, with operational costs being covered by either specificallyallocated portions of arants or from interest and dividend income.

The Foundation continues to work closely with the Old Boys' Association. The Class of 1972 met in November 2022 for their 50th Reunion, together with Old Boys from the Class of 1971 and 1973. We take this opportunity to thank them for the significant donations made to the Foundation to date.

#### Looking ahead

Our goal is to build on the achievements of the past sixteen years and further increase the number of young men who are supported on bursaries at St David's, especially now that the School has both Inanda and Alexandra campuses. For the forthcoming 2023 year, the Trustees have resolved to make an award in the amount of R4 226 759 (2022: R4 456 226) to the School specifically for bursary awards.

The Foundation could not exist without the support of our donors. As Trustees, we are humbled by your generosity and long-term commitment. I extend our very deep gratitude for every pledge, donation and bequest made by our donors over the last year.

I would like to make special mention of the significant contributions made by Lara Klement, the School's Head of Advancement, Fiona Budd, our Foundation Director and Moyagabo Motshekga, our Foundation Office Manager. Their selfless efforts, innovation and persistence resulted in a record collection of more than R4.3 million - a magnificent achievement. We thank the Foundation's accountants, Sergio and Vanessa Maraschin, as well as the Foundation's auditor Deidre de Meyer, for the professional manner in which they selflessly support these important functions for the Foundation.

To the School's Executive and Board of Governors, the Marist Schools' Council, the Advancement Office, the Marist Old Boys' Association and the rest of St David's Staff, thank you for your continued support of the Foundation, and caring for our boys.

I thank my fellow Trustees for the time and resources they dedicate to the Foundation.

In closing, I express our profound sadness at the passing of one of the Foundation's founding Trustees, and our Honorary Patron, Marist Brother Br Jude Pieterse, on 12 December 2022. Br Jude's gentle wisdom, and care for those most in need, leaves an enduring legacy in the Foundation, and we are deeply grateful for the life and influence of this exceptional, humble man. May his dear soul rest in peace.

### In Memorium HONORARY PATRON BROTHER JUDE PIETERSE (1939-2022) MHDSRIP


Br Jude was a man of immense courage and deep compassion who dedicated his life to the service of God and humanity. He leaves a remarkable legacy through the social justice work he did to help bring reform to our country, to transform our schools and through the many lives he impacted on a personal level. A man of conviction, yet humble and kind, a Marist of Champagnat in every respect.

Br Jude served as teacher, principal and Provincial in the former Marist Province of South Africa. He founded the Catholic Institute of Education and also served as secretary-general of the Southern African Catholic Bishops Conference. When the new Marist Province of Southern Africa was formed, he was appointed the first Provincial. The work that Brother Jude undertook in these roles is captured in the historically significant work, The Open Schools Era (1976 – 1986). Over the years he served on a variety of committees, Boards and Trusts, and was a founder Trustee of the St David's Marist Foundation, stepping down as a Trustee in July 2020. He then continued as the Honorary Patron of the Foundation.

Br Jude 'retired' to the Eastern Cape to assist with the Marist Outreach programme there and then returned to the Brothers' community at Sacred Heart College in the last few years. In an address given in 2012 at the St David's Marist Foundation donor evening, Br Jude quoted from Proverbs 29, "Where there is no vision, the people perish," challenging everyone present to continue working towards the vision of Marcellin Champagnat. Br Jude Pieterse dedicated his life to this vision and the challenge remains for each of us, now more than ever, to continue this work - to the Glory of God and in honour of a great Marist man, Br Jude Pieterse.

> Br Jude Pieterse passed away on the evening of 12 December 2022. We miss his presence, wisdom and great heart hugely, and have established the Br Jude Pieterse St David's Marist Alexandra Bursary Fund, to honour and continue his legacy.





### A Tribute to ANDY HALL (outgoing Chair of the St David's Marist Foundation)

In May 2022, after nine years of dedicated service to the St David's Marist Foundation as a Trustee, with the last five years of those as Chair of the St David's Marist Foundation, Andy Hall, CEO of Adcock Ingram, stepped down from the Foundation. Andy's steady and wise guidance through the years has made a tremendous contribution to the continuing growth and evolution of the Foundation. Andy and his wife Lynn have had a long association with St David's through their sons Travis (Class of 2015) and Justin (Class of 2016).

I want to wish you luck on your new journey. I also want to thank you and the team for your huge help and support in our lives. I hope I can also help another child like you helped us.

Being at St David's above everything means opportunity. An opportunity, a chance to better the economical place and situation my family is in. An opportunity to become a better me, an opportunity to more opportunities.

I would like to say thank you for your great impact towards my life. St David's is a safe space where I can express my feelings to my friends without anyone judging me at all.

### From the Head: **ADVANCEMENT 2022**

"Every man must decide whether he will walk in the light of creative altruism or in the darkness of destructive selfishness."

The Covid-19 pandemic taught us many things. Principally, not to take anything for granted, but equally, to be grateful – for family, for friendship, for health, for jobs, for freedom, for life!

It is somewhat surreal to think that we started 2022 still wearing masks, social distancing and still living in the shadows of this devastating virus. However, it was also the time when we slowly started to see the end of that dark tunnel. Whilst the light at the end of the tunnel was a bright one that heralded a return to some sense of normality, albeit a 'new normal', what sustained and guided us through the tunnel, was the light emitted by each kind word, compassionate act, thoughtful deed, empathetic ear, gentle touch and selfless sacrifice made by so many.

As we have reported before, the kindness and compassion shown by our extended community during the Covid pandemic was remarkable and carried us through this dark time. This altruistic behaviour actually predated Covid, but this crisis revealed the depths of this kindness and remarkably, has been sustained even post the pandemic!

The sense of urgency to 'do' that accompanied the freedom from lockdown brought with it a kind of frenzied need to make up for lost time and to take advantage of the light lest the darkness return. The latter half of the year was filled with much activity – opportunities to connect, celebrate, share, worship and heal. And for many people, much of this activity centred around the school as the return to office spaces was far slower for most than the return to school. As a school, we were not immune from the psychological pressure to make up for lost time and were motivated to just get going on some projects that had been on-hold due to various reasons.

What the Covid-19 pandemic highlighted in stark detail, and exacerbated further, is the deep divide between those who 'have' and those who 'have not', and access to education was an area that for us was most stark.



### From the Head: **ADVANCEMENT 2022**

A few years ago, we were presented with the opportunity to reopen a school in Alexandra township that had been started by the Holy Cross Sisters in the 1920s, but was forced to close its doors by the Apartheid government in the 1960s. A number of obstacles delayed us making a final decision, including missing title deeds and then two years of Covid-19. However, towards the end of 2022, in consultation with the St Hubert's Catholic Parish (on whose property the school is built), we decided to take a leap of faith and put a peg in the sand for a January 2023 opening of a Grade 8 class. We started with the Phase 1 renovations in November 2022 to ensure that we had a space ready for a small cohort of 'pioneer' Grade 8s, and also embarked on a fundraising campaign to enable us to continue with the renovations. The reopening of this campus, and all that it would represent, caught the imagination and touched the hearts of many. With the concerted and dedicated efforts of the team, and the generosity of donors, we were delighted to open the St David's Marist Inanda Alexandra satellite campus at the start of the school year in January 2023 - with much excitement from all stakeholder groups!

In opening our Alex Campus as a low fee-paying extension of our school, we have introduced what we believe is a new educational model that leverages off the strong brand and offering of a St David's Marist Inanda, and brings the community of Alex to the table in an empowered way that gives opportunity and invites the parents and the broader community to play a vital role in the school's success. Critical to the success of this model is the partnership with corporates, individuals and organisations that share the vision for a more equal and just South Africa where all children have access to quality education. We believe that this social compact between 1. St David's Marist Inanda, 2. the Alex community and 3. Business and Civil Society, creates a model for success, sustainability and replication. It also breaks down the walls between wealthier and poorer communities, acknowledging our common humanity.



### From the Head: **ADVANCEMENT 2022**



As with the birth of a new baby into a family, the St David's Marist Inanda Alex Campus brought with it, even in its early stages of renovation and then opening, excitement, hope, joy and anticipation for a bright future. The exponential increase in the number of boys that can receive a St David's Marist education in their own community is a way for us to shine light into the place of darkness that a lack of quality education and opportunity brings, and we see a bright future for the boys who will attend the school in the future.

As indicated, the success of the Alex Campus is dependent on a strong social compact that recognises that the success of this model is reliant on all role players coming to the party and we thank all those who have already done so. A vital component of this model is, however, the nurturing and support of the greater St David's structure, and we will continue to grow our current bursary programme to the Inanda campus, the development of the campus itself and other programmes and initiatives that ensure that St David's remains and grows as a world class educational institution, rooted firmly in the Marist ethos and values. The success of the greater St David's is equally reliant on the support, generosity and 'light' of those who believe in who St David's is and what it does and who believe, as we do, that excellence in and access to quality education is core to the sustainability and grown not only of our wonderful school but to our beautiful country.

We thank once again, all who have journeyed with us and who have been generous in supporting us financially, with their time, goodwill and prayers – especially through the past few years. The future of St David's looks bright, and we hope that the light that it brings will continue, as we are urged to be in the Marist Chapter Calls to be 'a global charismatic family, a beacon of hope in this turbulent world.'


#### Lara Klement Head: Advancement


The Foundation was able to make a 2022 award of just under R5 million to St David's Marist Inanda, primarily to fund 23 bursary scholars in the College. Six of the Foundation-funded bursary scholars matriculated, achieving excellent final results and commendations.

The St David's Marist Foundation is very fortunate to be able to work together with a wonderful array of donors and supporters. These include private individual donors, St David's families, St David's Old Boys, St David's Staff, St David's Circles (the St David's Bookclub Circle, run by the Swop Shop Moms volunteers, led by Joanne Oertel, with all proceeds from the Swop Shop and book sales being donated to the Fr Bernard Brewer SJ Bursary Fund, the St David's Water polo Circle and the St David's Friends of the Arts Circle), corporate companies, local foundations and trusts and international foundations and trusts. We are also partnered with the St David's PTA on the School-Days loyalty card programme. All funds raised are to support the strategic, developmental, transformational and philanthropic objectives of St David's Marist Inanda.



Our major bursary funders, including the Batho Batho Trust, the Karl Flowers Trust, the Investec Charitable Trust, the Temba Bavuma Foundation and Watprop, demonstrate the power of philanthropic partnerships in bringing about a life-changing impact through access to a quality education. We were so pleased to be able to welcome aboard SR Energy and Flow Communications as new bursary funders during 2022. This Annual Report includes a full list of our treasured donors.

The School's appointment of Mr Siqamo Laphu as the St David's Bursary Programme Coordinator in March 2021 continues to bring significant benefit to the ongoing growth and development of the Bursary Programme as a holistically structured model of allround support for the bursary scholars. The multi-faceted support also includes a mentoring programme with St David's Old Boys.



### **Crypto Philanthropy**

In August 2022 the St David's Marist Foundation became the first South African nonprofit to be registered on the international cryptocurrency donation platform The Giving Block. Crypto Philanthropy is the fastest growing area of philanthropy globally, and the Foundation is now able to receive cryptocurrency donations from anywhere in the world, including South Africa, fully vetted by The Giving Block.



The Team Marist Champagnat Day 'virtual' Run, uniting all five of the South African Marist Schools – St David's Marist Inanda, Sacred Heart College and Marist Brothers Linmeyer in Johannesburg, St Henry's Marist College in Durban, and St Joseph's Marist College in Cape Town – returned for its second year in 2022. 779 participants took part across the five South African Marist Schools, with 171 participants from St David's. International participants (including St David's Old Boys and Past Staff) took part from Framlingham, UK;



Knoxville Tennessee, USA: London, UK; Madrid, Spain; Perth, Australia; Trou Aux Biches, Mauritius; Walton on Thames. UK: and New York. USA. All participants received a Team Marist participation virtual medal. The participation distance was once again 4km - the distance that St Marcellin Champagnat, Founder of the Marist Brothers teaching order, walked each day between The Hermitage and La Valla-en-Gier (where his first school was situated). One-fifth of each school's funds raised were donated to either the Marist Brothers' Marist Mercy Care (in the Eastern Cape) or to the Three2Six Programme at Sacred Heart College.







### **Christmas Giving 2022**

### St David's Marist Inanda Bursary Programme - **EXCELLENCE AND ACCESS**



The St David's Bursary Programme provides funding for young boys with potential.

St David's Marist Inanda, an all-boys school in Sandton, Johannesburg, is an African Marist Catholic school committed to educational excellence. St David's believes that a quality education based on sound values is imperative in shaping the lives of our youth and transforming our country into an equitable and just society.

#### **Building Bridges of Hope** and Support

The St David's Bursary Programme has, over the past 15 years, formalised into a more structured programme of holistic support, built upon learnings and feedback from previous bursary scholars.

While exciting, it is daunting for a Grade 8 bursary scholar to join the school. Helping them to have the best possible experience, support and opportunity to thrive requires a carefully guided approach.

Learnings built into our bursary programme include:

- A complete analysis of what the bursary funding needs to cover (only covering tuition fees is not feasible).
- Psychosocial support from our wellness department. Ensuring that the bursary scholar's parents/guardians are part of their son's life at St David's and are able to attend parent-teacher meetings and school events.
- A bursary programme co-ordinator who serves as the central point of contact within the school, and connects and updates the St David's Marist Foundation on awardees' progress.
- Termly breakfast mentorship meetings

to engage and connect with the bursary scholars and receive their open and honest feedback on how to further build and strengthen the programme.

### *Identifying a Bursary Candidate*

Potential bursary candidates are identified by the school, in partnership with the Alexandra Education Committee, the Student Sponsorship Programme, and feeder schools and partners. Bursary applications are also received via the school's admissions office, which manages the assessment and interview process to identify boys with the potential to thrive at St David's. This process includes a financial needs analysis of the family, and the school proposes a funding budget to the St David's Marist Foundation to support a number of the identified candidates. The school and foundation aim to meet as many of the needs and costs as realistically possible to ensure a bursary scholar's best possible chance of success at St David's.

Weekly boarding was reopened in 2018, and several of the bursary scholars have been accommodated to enable them to engage as fully as possible in school life and activities, as well as being able to study and complete homework with Wi-Fi and in a conducive study environment. Non-boarders are provided with data and a Wi-Fi router to assist them with



studying at home. The scholars also receive a small monthly allowance to purchase personal items or visit the tuckshop with their friends.

#### *The Power of Philanthropic Partnerships*

A key objective of the foundation is to increase the number of bursaries at St David's, with the aim of having five bursaries per grade.


The foundation's donors include private individual donors, St David's community donors (parents, old boys and past parents), corporate companies, local and international foundations and trusts, and the St David's staff, many of whom contribute to the Staff Giving Fund. Funders and trustees of the foundation also include previous St David's bursary scholars.

Partnering with even more like-minded donors and funders is key to making access to quality education a reality for boys for whom this would otherwise be an unattainable dream. St David's Marist Inanda and the St David's Marist Foundation are committed to educational excellence and creating access to our excellent school, in support of our own Marist ethos, our country's needs and the United Nations' Sustainable Development Goal No 4 – Access to Quality Education.







#### TOTAL BREAKDOWN OF DONOR SECTORS



### Funds and **PROGRAMMES**

The Foundation can receive both restricted and unrestricted donations. Unrestricted donations are allocated and utilised at the discretion of the Trustees for the purposes that conform to the mission of the School; this provides important flexibility to the Trustees and the School Executive. Restricted donations meet the specific aims of donors who may wish to direct their giving at other projects or objectives.

A taxpayer making a *bona fide* donation in cash or kind to the Foundation (an organisation approved in terms of Section 18A of the Income Tax Act 58 of 1962) is entitled to a deduction from their taxable income of the amount donated and the Foundation issues the donor with a tax certificate entitling the donor to claim the donated amount as a deduction (up to 10% of taxable income).

The funds indicated below are the established Foundation funds.

#### **Endowment Fund**

The Endowment Fund is an investment Fund set up to provide long-term sustainable



support to St David's Marist Inanda, as well as annual liquidity to support Foundation Bursaries and projects if required.

### **Bursary Funds**

#### Father Bernard Brewer SJ Bursary

The Father Bernard Brewer SJ Bursary Fund enables St David's to support deserving boys with potential from previously disadvantaged backgrounds, and is the main Bursary Fund of the Foundation.

#### The Business in Education B-BBEE Bursary Fund

#### 'Growing tomorrow's business leaders together'

The Business in Education Fund was created to enable corporate and business enterprises to partner with the Foundation in realising measurable and quality education intervention programmes through full bursaries to St David's for identified learners from historically disadvantaged backgrounds. The introduction of the Revised Broad-Based Black Empowerment Codes of Good Practice created various opportunities through which

corporate and business funders can benefit when making contributions to the St David's Marist Foundation.

The Foundation has both the structure and the strategic approach through which to successfully engage enterprise in this arena and was specifically designed to allow for the separate accounting and reporting process required by the B-BBEE Codes, to give corporate funders maximum scoring benefit in the SED (Socio-economic Development) and SD (Skills Development) categories.

#### **Mizpah Bursary Fund**

The Mizpah Bursary Fund ('Mizpah' is a Biblical term meaning 'words of blessing, protection and inspiration') was founded in August 2017 by a Bursary Recipient who matriculated at the end of 2017. His wish in founding the Bursary, with an initial R1 000 that he had raised through his own efforts, is that future boys in need will be able to have the same opportunities as he enjoyed at St David's.



#### Willy & Dorothy Castle Extramural Bursary

The Willy & Dorothy Castle Extramural Bursary, named in honour of Willy Castle, and his mother Dorothy Castle, is awarded to boys who show promise in the areas of sport or cultural whilst being able to maintain the required academic standard.

#### **Tertiary Education Bursary Fund**

The Tertiary Education Bursary fund provides tertiary bursary support (following the approval of an official approach) for St David's past pupils wishing to pursue a teaching qualification or funding donated by specific donors towards their St David's bursary recipient's tertiary education

#### requirements.

#### **Old Boys' Bursary Fund**

The St David's Marist Old Boys' Bursary is a grant that is awarded by the Marist Old Boys' Association either to the son of an Alumnus or to a candidate identified by the Association.

#### **Staff Giving Fund**

The Staff Giving Fund currently assists numerous learners with support for uniforms, books, the payment of school tours, and other incidental costs.

### Family Funds

A Family Scholarship Fund can be set up in memory of a loved one, in celebration of the blessings you have received as a family, as a family legacy or just to make the difference in the life of a boy who would otherwise not have had the opportunity to attend St David's, but without the administrative burden or fiduciary responsibilities to you involved in establishing an independent Trust.

### Funds and **PROGRAMMES**

Multiple family members and friends can contribute directly to the fund and benefit from the tax benefits. Contact us to discuss establishing a Family Fund or Scholarship under the banner of the St David's Marist Foundation. A Family Fund or Scholarship aims to ensure that a boy (or boys) attend St David's in your family name in perpetuity, i.e. a new boy is awarded a scholarship in your name upon the Matriculation of the previous beneficiary. Alternatively you may ask that your Fund is utilised according to the Trustees' discretion for the benefit of St David's Marist Inanda.

# St David's Marist ALEXANDRA

A High School campus of Hope and Restoration




Alexandra, carrying deep scars of Apartheid, lies alongside some of the wealthiest areas of Johannesburg, making the severe poverty and deprivation in the township a stark contrast to the wealth of Sandton (the richest square mile in Africa) just 3 miles away. An estimated 350 000 people reside within just over 1 square kilometre and 70% of the population is estimated to be under 35 years of age (the official South African limit for the category 'youth'), in a country with a youth unemployment rate of 66.5%.

There is a chronic lack of access to affordable, quality high school education in Alex. The education system is severely constrained, and many children fall through the cracks and drop out of school, perpetuating the cycle of poverty and unemployment. The impact of the Covid pandemic and lockdowns exacerbated an already dire situation. For St David's, addressing this disparity is a critical part of our evolving educational model and Marist mission.

St David's Marist Alexandra had been in planning since 2014. Finally in 2022, many pieces of the puzzle (including locating the Apartheid-appropriated, then lost title deeds for the land) came together to allow St David's to work together with the Alexandra Catholic Parish and community to re-establish a quality high school campusin the heart of the community. Marist Alex, which launched in January 2023, is a satellite campus of St David's Marist Inanda, with a strong STEAM focus and shared resources with St David's.


# Montagne Day and Montagne Day Pledge Campaign 2022 FRIDAY 28 OCTOBER


