FROM THE CHAIRMAN



This report covers the 2019 Financial Year and includes extracts from the audited Annual Financial Statements for the year ended 31 December 2019.

It is my pleasure to introduce the St David's Marist Foundation's 2019 Annual Report to you. To provide you with assurance on how the Trustees collectively manage the Foundation's income and capital, I begin my report with a reminder of the core objectives of the Foundation:

- **The main object is to receive donations from third parties for the purpose of:**
 - o applying such funds for education and development at the School; and
 - o the provision of support services to, or the promotion of, the common interests of the School.
- **Furthermore, the Foundation may provide funding and support services in the furtherance of the main object of the Foundation for other purposes such as:**
 - o the provision of related and associated education and development courses in relation to academic enrichment, academic support, supplementary tuition or outreach

programmes for the disadvantaged and the provision of scholarships, bursaries and awards for study programmes, research and teaching;

- o to erect or contribute to the cost of erection of any buildings required for or incidental to the promotion of the purpose and objectives of the Foundation;
- o to supplement the salaries of any existing or future teachers at the School; and
- o to initiate and participate in fundraising ventures to raise funds to promote the objects of the Foundation.

Other key subsets of the objects include:

- securing long-term, sustainable funding for the School;
- raising the capital required to support bursary and development programmes from the income derived from such capital; and
- promoting meaningful transformation within the School.

Central to these objects is ensuring that St David's boys receive a balanced education, grounded in the Marist philosophy, and to maintain the standards and promote the diversity required in South Africa.

The Foundation's cumulative efforts over a thirteen-year period to date are presented below:

- Donations received: R23.03 million (2018: R20.3 million);
- Investment income, after expenses: R8.5 million (2018: R7.1 million);
- Realised and unrealised gains on investments: R12.4 million (2018: R11.0 million); and
- Awards made: R15.1 million (2018: R12.4 million).
- Net capital as at 31 December 2019: R28.7 million (2018: R25.9 million).

THE YEAR UNDER REVIEW

As Trustees we are deeply aware of our responsibility to manage the funds received by the Foundation in a judicious and prudent manner, taking into account the Foundation's commitment to sustainably support current bursary recipients and if possible

grow awards over time, as well as our duty of care to donors through the manner in which we manage their contributions.

Our goal remains to realise capital growth in excess of inflation, with a view to making annual awards of between 4% - 6% of opening capital to qualifying programmes and bursary recipients. This is in addition to donor-specific bursary funding which is received annually and goes directly to the bursary costs of the applicable recipient each year.

Through the Foundation's investments in the Centaur BCI Flexible Fund (Centaur Fund) and the Coronation Strategic Income Fund (Coronation Fund) the underlying asset allocation comprises a diversified spread in South African listed equities, preference shares, offshore investments, cash, bonds and property. Approximately 50% of the Foundation's funds are invested in the Centaur Fund, 40% in the Coronation Fund and the balance in interest-bearing money market deposits.

We were extremely proud to have five Foundation bursary recipients matriculate at the end of 2019 – all of these young men achieved excellent results, with one of the bursary recipients achieving a place in St David's Top Twenty Matriculants. In addition, these young men truly showed themselves to be

Marist men with Leadership awards, Honours Blazers and Champagnat Medal awards being amongst the highlights of their matric year. In 2020 two young men on Foundation bursaries will be writing their matric exams.

The Mizpah Bursary Fund, founded by one of the 2017 Matric bursary recipients to ensure that future boys in need will be able to receive the same opportunities he did at St David's, had, through donations and investment income, grown to R76 228 (2018: R36 000) by the end of 2019.

IN REVIEWING THE FOUNDATION'S ACTIVITIES IN THE 2019 YEAR THE FOLLOWING IS WORTH MENTIONING:

- The Foundation's fund-raising efforts raised a total of R2 751 915 (2018: R2 854 336). These included donor-specific awards of R1 604 994.
- The gain from investment activities before interest and dividends, net of expenses, amounted to R1 424 724 (2018: R1 011 890 loss). The total growth in the investment portfolio of the Foundation of 11%

LOOKING AHEAD

The goal of the Foundation is to increase the number of boys who are fully supported on bursaries at St David's over time, within our self-imposed constraints and taking into account the turbulent times being experienced in financial

markets. During 2019, 22 young men, who would otherwise not have had the benefit of a St David's education were supported by the Foundation.

The St David's Marist Foundation Office's strategy since 2015 has been to adopt a multi-faceted plan and approach to the concepts of giving and philanthropy. There are short, medium and long-term programmes and strategies in place, and these continue to gain traction as the awareness of the Foundation increases.

For the forthcoming year (2020), the Foundation has resolved to award an amount of R2 754 900 (2019: R2 807 669) to the School for bursary awards. It is evident that the huge generosity of our donors and the tireless work of our Foundation Manager is making a material impact in helping to develop some of our society's future leaders.

(2018: 0.5%), being capital growth plus interest and dividends, was a considerable improvement on 2018.

- Awards paid to the School amounted to R2 807 669 (2018: R1 711 792), an increase of 60%. Excluding donor-specific awards the award made by the Foundation comprised 5.2% of the Foundation's capital at the beginning of 2019.

Including donor-specific awards the award made by the Foundation comprised 10.8% (2018: 6.9%) of the capital at the beginning of the year.

- 22 young men were supported on bursaries in 2019 (2018: 17) and of these bursaries 6 included boarding at St David's.
- The Foundation's capital, after expenses and awards to the school, increased by 10.8% to R28 771 438 (2018: R25 947 357) as at 31 December 2019.

The Foundation's discretionary operational expenditure budget for 2019 amounted to R100 000, all of which was utilised in support of fund-raising development and initiatives. The School continues to cover the majority of the operational expenses of the Foundation office.

The Foundation is resolved to becoming sustainable, without financial support from the School. Reasons for this include the intention to remove this particular cost burden from the School and, more importantly, that certain overseas organisations we approach for funding require



operational costs to be included in any funding proposal as they recognise that an organisation of the Foundation's nature should be sustainable on an independent basis. It remains our objective that 100% of donor funding will always go to the purposes intended, with operational costs being covered only by specifically-allocated portions of grants, or from interest and dividend income.

Finally, the Foundation continues to work closely with the Old Boys' Association in supporting their specific donor funds and growing the Alumni community.



The Foundation could not exist without the support of our generous donors, a number of whom have shown amazing long-term commitment to our objectives, and year after year continue to recognise the difference they are able to make in giving the precious gift of a Marist education to under-privileged boys. We recognise that every donor's contribution is made in today's immensely challenging economic circumstances, balanced against the needs of other worthy causes. I extend very deep gratitude on behalf of the Trustees and the School for all the pledges, donations, bequests and other contributions made by donors over the last year. I must make

special mention of the contributions made by Lara Klement, the School's Head of Advancement, and Fiona Budd, our Foundation Manager. Their selfless efforts, innovation and persistence are reflected in the donations received in 2019 of almost R2.8 million – a magnificent achievement. I also wish to thank my fellow Trustees. It is a privilege to serve alongside you all.

In particular, I would like to thank Dr Gianni Mariano, one of our founding Trustees, who will be stepping down at the end of February 2020. His years of selfless Marist service and contribution, since the inception of the Foundation, leave a legacy that we are proud to continue to build on

- his impact is best reflected in the words of Lara Klement (Head: Advancement) in the thanks to him that follow this report.

Mr Brian Kalil stepped down in early 2019, following the completion of the 2018 audit, after 11 years of dedicated and professional service in a pro bono role as the auditor of the Foundation. We were delighted to welcome Accvantage Solutions as the Foundation's new auditors in March 2019, again in a pro bono role, and thank Sergio and Vanessa Maraschin and Adri du Plessis for the seamless and professional way in which they have taken over this important function for the Foundation.

Finally, to the School's Executive and Board of Governors, the Marist Schools' Council, the Advancement Office, the Marist Old Boys' Association and the St David's Staff, thank you for your continued support.

Although this report is written in reflection of the 2019 financial year, I am writing this report whilst in 2020 Corona-19 Lockdown and it would be thoughtless not to reflect on this time, but also the future, through the lens of Covid-19 and the changes it has wrought in our school and on our lives in a relatively short space of time.

Our 2020 Head of School, Nqubeko Mthabela, in a video message to the boys of St David's a couple of weeks into lockdown, made a seemingly simple statement that has proved to be of profound significance as time has moved on and the impact of this pandemic felt and seen.

“Gentlemen... crisis does not build character; it only reveals it...”

The Covid-19 Pandemic has indeed revealed character, and in some cases, the lack of it. This unprecedented situation has challenged every person, family, organization, community and country on many levels, and we have been put to the test in terms of resilience, processes,

policies, finances, agility, values, relationships and even faith.

At a time when little has felt normal and we have had no frame of reference with which to navigate this 'new normal', we have all had to very quickly adapt, reframe, innovate, etc. and whilst it has been stressful, it has also challenged us in new, interesting and sometimes scary ways. It has pushed us into places and spaces that either we have not thought of entering or have been thinking about and planning to enter gradually or at some time in the future. The need for an accelerated rate of change has, in many ways, nullified or reduced the obstacles that would have traditionally either stalled or impeded change and we have recognized in the process that many of these obstacles are self-imposed. These obstacles manifesting in many forms: finding comfort and safety in traditional ways of thinking and behaving, fear of the unknown and fear of failure, not wanting to alienate relationships and so the list goes on. However, the very real sense of 'sink or swim' has galvanized us to tap into parts of ourselves, individually and collectively, that have been dormant, suppressed or even unidentified until placed in this unprecedented position.

The results have been, in many ways, surprising, energizing, liberating and gratifying.

As has been reflected in the previous reports by Mr Andy Hall and Ms Fiona Budd, 2019 was by all accounts a successful year for the school and for the Foundation, despite an already challenging socio-economic climate in South Africa. A number of strategic conversations and plans to both leverage off this position as well as mitigate against increasingly challenging financial circumstances had taken place and some exciting plans, particularly around the development of our campus had been presented in various forums. However, 'the best laid plans...'



ST DAVID'S, AS A SCHOOL, HAD TO RESPOND ALMOST OVERNIGHT TO THE REALITIES OF AN IMMINENT LOCKDOWN AND CLOSURE OF SCHOOLS AS THE THREAT OF COVID-19 BECAME A REALITY IN MID-MARCH.

The school, under the decisive and confident leadership of Mr Mike Thiel and Mr Nick Clogg, responded swiftly and effectively and within a few days had transitioned to **"St David's Online"** across the grades, with teachers very quickly setting themselves up to teach from home using a range of technologies, platforms and innovations to deliver lessons at an age-appropriate and impactful manner. The learning curve has indeed been steep and, at times, stressful for all involved. However, the collaboration between teachers, parents and pupils has been remarkable, with the wellbeing of the boys remaining central. With a full online programme from our Sports and Cultural Departments, and support from our Wellness Department,

our boys have received an amazing online offering. However, perhaps the greatest insight through this time has been recognising just how important physical and social interactions are to our sense of self (again, both individually and collectively) and our happiness and our aim is to have our boys and staff fully back on campus as soon as it is safe enough to do so.

There is much that we have learnt about the power of technology and how it offers opportunities to connect on a local, national and global level, how it provides the ability to create access and scalability beyond the confines of the physical environment, how it enables and encourages collaboration and sharing etc. and much of this learning will inform how we do things moving forward and we are excited about the possibilities this already presents for us. However, we have also learnt that much of the success that we have achieved through technology has been built off a basis of strong existing relationships between people (staff and boys, staff and parents, staff themselves, management and staff etc.) and this has reiterated for us the importance of building and nurturing these human relationships within our community.

However, to not acknowledge our position of privilege that has allowed us to achieve this level of success would be both arrogant and immoral. Whilst we are highly aware of the vast inequalities that exist in our country and how these translate into every aspect of people's lives, including education, Covid-19 has both highlighted and exacerbated these inequalities.

As a school and a Foundation, we have been 'confronted' with the realities of these inequalities and our response to them in a number of ways during this time. A concerted and focused effort by our Wellness Department, Finance Department and the Foundation to ensure that boys on our bursary programme have had the necessary IT and WIFI infrastructure and access has been a priority to ensure that no boy is educationally disadvantaged during this time. The Foundation Trustees approved an additional ex-gratia payment to the school to ensure that these needs and any other basic needs of the boys and their families were taken care of and this has been used to provide support to these families and others who have needed it thus far. The St David's Marist Foundation often quotes St Marcellin Champagnat's words, "to teach children, we need to love them, and love them

all equally” and how one of the responsibilities of the Foundation is to ensure that the boys on our bursary programme have what they need to give them an equal chance of success to any other boy at St David's. With the boys being off-campus, we have been challenged on a very personal level to deepen our understanding of what this actually means and what this support should be in order to further level the playing fields for our boys. As a school we have also been challenging ourselves, with the insights we have gained over this time, to look at ways we can leverage our resources even further to create access to quality education to disadvantaged communities through technology.

If anything, our resolve to answer the Marist Chapter Prayer, which calls us to...

*...as a global charismatic family,
a beacon of hope in this turbulent world,
to be the face and hands of your tender
mercy.*

*Inspire our creativity to be bridge-builders,
to journey with children and young people
on the margins of life,
and to respond boldly to emerging needs.*

Our ability to meet the needs of our boys and their families has only been possible due to the generosity of our donors and I extend, on behalf of the school, our sincere gratitude to every donor whose has generously contributed to the Foundation over time and which has allowed us to respond with compassion and humanity during this time.

Perhaps our greatest learning during this time of great instability and uncertainty has been that 'that which is true, will stand'. Whilst so much has changed and will continue to change moving forward, we have remained anchored by our Marist values. Now, more than ever, the values of humility, simplicity and modesty seem particularly relevant and essential to both guiding us through the uncertainty and in finding a 'new normal'.

As a school and as a Foundation, we remain committed to ensuring that the Marist approach to education, based on these timeless values, and which nurtures the character needed to face the inevitable challenges that the future will present, will be sustained and grown.

In closing, my sincere thanks to the St David's Marist Foundation Trustees, under

the Chairmanship of Mr Andy Hall, for their continued support, wisdom and generosity; to the St David's Marist Inanda Board of Directors for their ongoing support of the work of the Foundation, to the School Executive for so ably and courageously steering the ship through these turbulent seas and to all St David's staff, in whatever capacity, who touch the lives of the St David's boys in their daily care either directly or indirectly. A very special note of sincere gratitude to Ms Fiona Budd for the energy, intellect and passion she brings to her work as Foundation Manager, and for ensuring that the impact of the Foundation continues to grow each year. It is indeed a privilege to work with each of these individuals.

At the November 2019 launch of the Nedbank Private Wealth Giving Report IV the words of Professor Mamokgethi Phakeng, Vice-Chancellor of the University of Cape Town, encapsulated the world and work of the donor, gift-giver and philanthropist: "Giving makes me feel human."

Thank you to each and every member of our St David's community who contributed to the Foundation during 2019 – whether as a donor in any capacity, a member of one of the Circles of Friendship, a member of our Team St David's Inanda Pandas Team who rode the Discovery 947 Ride Joburg, a supporter of one of the Foundation's annual campaigns (such as Christmas Giving) or through the sharing of your time, talents and donations-in-kind.

The Foundation's donors and benefactors include private individual donors, St David's Parents and families, St David's Past Parents, St David's Staff (during 2019 36 Staff, contributing on a monthly basis, donated a total of R65 000 to the Staff Giving Fund – a fund set up to assist any boy in need at St David's), St David's Old Boys, the business world (local corporate companies and small businesses to the Foundation's Business in Education B-BBEE



Bursary Fund, which qualifies donors to receive SD and SED points), local and international charitable trusts and grant-making organisations, and the St David's boys themselves, through the annual Montagne Day Pledge initiative. The collective efforts and support of all of our donors resulted in donations received of R2.7 million in 2019. The annual funding award that the Foundation Trustees approve to make to St David's Marist Inanda for bursaries frees up funding for the School to be able to support further boys and families requiring financial assistance within the School.

THE ST DAVID'S MARIST FOUNDATION BURSARY FUND

During 2019, thanks to the generosity and vision of our donors, the Foundation was able to support 22 young men from financially-disempowered

communities on bursaries (up from 17 in 2018). A bursary is only awarded if the Foundation has the funds to ensure that the recipient will be covered for the full duration of their St David's education – thanks to long-term commitments from donors and funders the Foundation has been able to increase the number of bursaries supported. Bursary support includes ensuring that the recipients have all the equipment and support that they need to offer them the best possible chance to thrive and flourish at St David's and there is a vast network of support in place at St David's to assist with this. The primary Bursary Fund is the Father Bernard Brewer SJ Bursary Fund, established in the memory of Father Brewer, a previous Chaplain at St David's. Other Bursary Funds under the Foundation include the Business in Education B-BBEE Bursary Fund and the Mizpah Bursary Fund, founded and named by a 2017 Matric Bursary recipient who wished to ensure that future boys in need could also have access to what he had received at St David's, and launched with R1 000 that he had raised through his own efforts. At the end of 2019 Mizpah had grown to over R70 000 in funds raised through the support of donors and dividends from investment. The Foundation also manages the Old Boys' Bursary Fund for the Old Boys' Association.

SOME FOUNDATION HIGHLIGHTS FROM 2019

Foundation Philanthropy and Business Networking Breakfasts

Three Breakfasts took place this year – the aim of the Breakfasts is to offer a platform for the St David's community to be introduced to a variety of philanthropic options offered by experts in the field, as well as offer an opportunity for business networking and connecting. Mike Thiel, Executive Head of St David's, was the speaker at the Term 1 Breakfast, sharing the School's vision and strategic development plan, plus ways in which this can be supported by the St David's community, the speaker

at the Term 2 Breakfast was Thierry Dalais (St David's Old Boy (Class of 1975), one of the Founder Trustees (and first Chairman) of the St David's Marist Foundation, and a Founder and the Executive Chairman of Metier) who shared his philanthropic journey, and the Term 3 Breakfast was presented by Jacquie Howard and Maxine Gray of Investec Wealth and Investment Philanthropy, who shared Investec's philosophy of 'Creating a Legacy beyond Wealth'. Investec Philanthropy, through their managed Philanthropy foundation investments, support Education, Welfare & Humanitarian, Social Justice and Healthcare initiatives. It was lovely to be able to welcome and engage with many of our St David's Parents, Old Boys and Staff at these breakfasts.

Circles of Friendship News and Highlights

The **Friends of the Arts Circle** (founded by Marina Appelbaum, and now headed by Tanya King) gave magnificent support to the Cultural Department during this year's superb College production of 'Footloose' which presented as a Supper Theatre show. Since inception this Circle has raised R112 000 towards Cultural Development at St David's.

The **Book Club Circle** (the very first Circle, launched by the Swop Shop Moms in 2016) and run out of the Swop Shop, led by Joanne Oertel, sell good quality, second-hand books (in support of the Father Bernard Brewer Bursary Fund). The Bookclub Circle also have a stall at the Annual St David's Christmas Market. Since inception this Circle has raised R29 000 towards the Bursary Fund.



The **Water Polo Circle** (launched in September 2017 in support of Sports Development, specifically around Water Polo and headed by Kirsten Ferriman-Else and Jeanine Cooper) have supported at events such as the Water Polo Currie Cup held at St David's earlier this year. They have raised R73 000 since their launch and have been able to support several boys in need again this year, by covering their Waterpolo tour costs, as well as development costs and requirements for Water Polo at St David's.

In October 2019 I was privileged to be one of 20 fundraisers from around the world invited to attend the Resource Alliance's International Fundraising Congress in the Netherlands, as a Session Leader. IFC is known as 'the' event each year where the greatest minds in the fundraising, social impact and philanthropy spaces come together from around the world. With 1000 delegates in attendance, and over 100 speakers, the sessions range from interactive Master Classes and workshops, to plenary sessions and big room talks. IFC participants work for organisations

ranging from major global non-profits such as the International Red Cross, Greenpeace and UNICEF, to small local organisations where they may be the only fundraiser supporting the entire organisation (such as the St David's Marist Foundation).



Montagne Day Pledges 2019

On Thursday 24 October, St David's commemorated the 203rd Anniversary of the day on which the young Marcellin Champagnat encountered Jean-Baptiste Montagne, a young boy who was on his deathbed but had received no spiritual or academic education and an encounter which inspired St Marcellin to found the Marist Brothers teaching order. In 2019, boys from 87 St David's families donated a total of R20 000 in support



of a bursary for a modern-day boy in need. The aim of the Montagne Day Pledge initiative is to encourage the next generation of young philanthropists and for our St David's boys to realise the power of collective giving - each boy contributing a little amount (R100 each) creates a meaningful and significant whole with the potential to change the trajectory of a life forever.

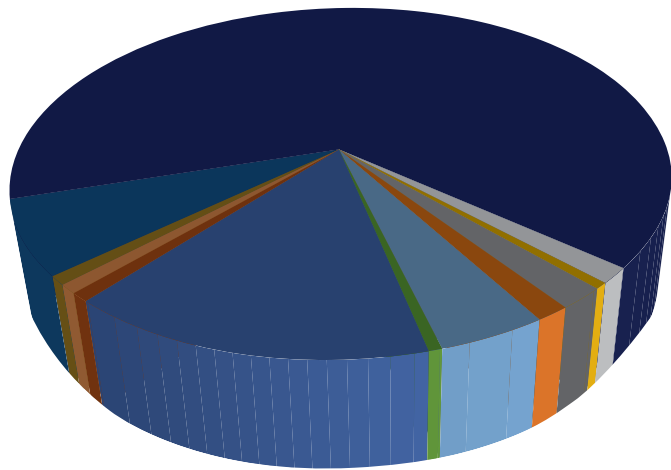

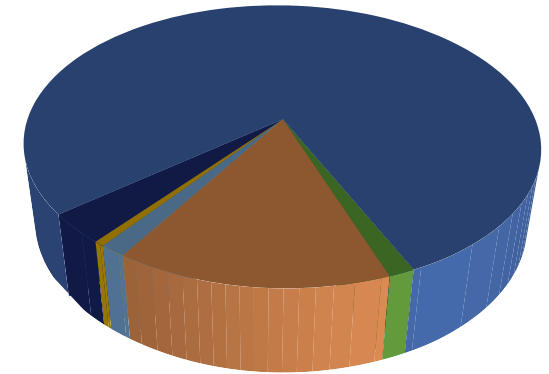

*Centaur Asset Management has been mandated to invest monies on behalf of the Foundation with a view to long term out-performance (of JSE listed equities) and an annual liquidity need of 4% - 6% of the gross capital under management, at the beginning of each year.



The Foundation can receive both restricted and unrestricted donations. Unrestricted donations are allocated and utilised at the discretion of the Trustees for the purposes that conform to the mission of the School; this provides important flexibility to the Trustees and the School Executive. Restricted donations meet the specific aims of donors who may wish to direct their giving at other projects or objectives.

A taxpayer making a bona fide donation in cash or kind to the Foundation (an organisation approved in terms of Section 18A of the Income Tax Act 58 of 1962) is entitled to a deduction from their taxable income of the amount donated and the Foundation issues the donor with a tax certificate entitling the donor to claim the donated amount as a deduction (up to 10% of taxable income).



ENDOWMENT FUND

The Endowment Fund is an investment Fund set up to provide long-term sustainable support to St David's Marist Inanda, as well as annual liquidity to support Foundation Bursaries and projects.

BURSARY FUNDS

Father Bernard Brewer SJ Bursary

The Father Bernard Brewer SJ Bursary enables St David's to support deserving boys with potential from previously disadvantaged backgrounds.

Mizpah Bursary Fund

The Mizpah Bursary Fund ('Mizpah' is a Biblical term meaning 'words of blessing, protection and inspiration') was founded in August 2017 by a Bursary Recipient who matriculated at the end of 2017. His wish in founding the Bursary, with an initial R1 000 that he had raised through his own efforts, is that future boys in need will be able to have the same opportunities as he enjoyed at St David's.

Willy & Dorothy Castle Extramural Bursary

The Willy & Dorothy Castle Extramural Bursary, named in honour of Willy Castle, and his mother Dorothy Castle, is awarded to boys who show promise in the areas of sport or cultural whilst being able to maintain the required academic standard.

Tertiary Education Bursary Fund

The Tertiary Education Bursary fund provides tertiary bursary support (following the approval of an official approach) for St David's past pupils wishing to pursue a teaching qualification or funding donated by specific donors towards their St David's bursary recipient's tertiary education requirements.

Old Boys' Bursary Fund

The St David's Marist Old Boys' Bursary is a grant that is awarded by the Marist Old Boys' Association either to the son of an Alumnus or to a candidate identified by the Association.

Staff Giving Fund

The Staff Giving Fund currently assists numerous learners with support for uniforms, books, the payment of school tours, and other incidental costs.



FAMILY FUNDS

The Business in Education Fund was created to enable corporate and business enterprises to partner with the Foundation in realising measurable and quality education intervention programmes through full bursaries to St David's for identified learners from historically disadvantaged backgrounds. The introduction of the Revised Broad-Based Black Empowerment Codes of Good Practice created various opportunities through

which corporate and business funders can benefit when making contributions to the St David's Marist Foundation.

The Foundation has both the structure and the strategic approach through which to successfully engage enterprise in this arena and was specifically designed to allow for the separate accounting and reporting process required by the B-BBEE Codes, to give corporate funders maximum scoring benefit in the SED and SD categories.

PROJECT, FACILITIES & DEVELOPMENT FUNDS

The Foundation seeks to provide St David's with funding support for development of the School campus facilities to enhance and support curriculum activities and enable students to experience an education at the highest level, through the following five funds.

Capital Development

Provides funding support for the development of the School campus facilities to enhance and support curriculum and extra-curriculum activities and enable students to experience an education at the highest level.



Leadership Development

Provides funding support for programmes and projects to assist in developing the leadership potential and ability of students to the highest level.



Cultural Development

Sports Development

Provides funding support for programmes and projects to assist in developing and growing the sporting potential and ability of students to the highest level.

Community Development

St David's Marist Inanda is currently involved in over twenty-four community involvement and service projects across the Preparatory and High School. Programmes include educational support and enrichment, sports development, feeding programmes, project visits and financial and resource donations. The projects are all very hands-on with St David's boys expected to actively initiate, lead, participate in and commit to programmes and projects. Each year a major project is undertaken by the Grade 11 'Hands of Champagnat' group. The School's project selections are guided by the Key Strategic Drivers (KSDs) that underpin all activities that take place at St David's, and the St David's Marist Foundation assists where required with guidance, support and donor funding administration and channelling.

Maristonian Project Fund

The St David's Marist Foundation administers the receipt of funds and donations towards the St David's Old Boys' Association's Maristonian Project – a project which includes the building of a home base for the Old Boys' Association.

THE MARIST LEGACY (BEQUESTS)

This Fund offers donors the opportunity to leave a Lasting Marist Legacy through a Bequest to the St David's Marist Foundation. The impact of a bequest reaches far into the future and beyond a lifetime.

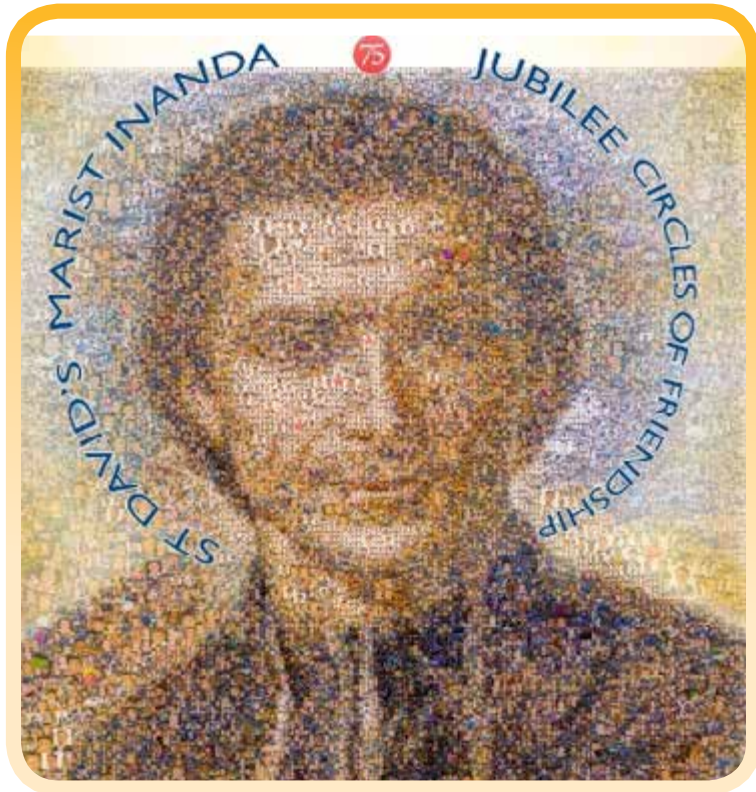

MATRIC CLASS YEAR CIRCLES

Montagne Day, and the Montagne Day Pledge campaign, was launched at St David's Marist Inanda in 2016, in remembrance of St Marcellin Champagnat's meeting with the dying young Jean-Baptiste Montagne on 28 October 1816 – a meeting which inspired his vocation to found the Marist teaching order. In the spirit of the 75th Jubilee and the Marist value of 'Love of Work', each St David's boy was encouraged to raise, through his own efforts or acts of service, R75 to contribute to the Jubilee Circles of Friendship initiative, in support of a Bursary for a young boy in need. These donations formed the start of each year group's own Jubilee Circles of Friendship as per the Matric Years that they will eventually become, for example, those boys who were in Grade 6 in 2019 will be the Matric Class of 2025.

Montagne Day takes place each year at St David's on or around 28 October, with the aim of encouraging the St David's boys to become the next generation of young philanthropists - during 2019 each boy was encouraged to raise R100 towards his Pledge. Over 100 boys contributed donations of R100 or more, and funds of R20 100 were raised towards the Bursary Fund.

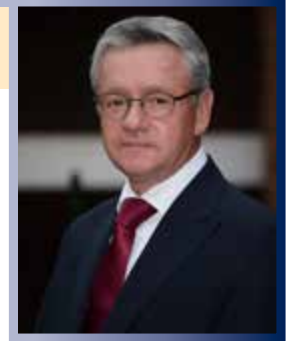


MEET THE TRUSTEES

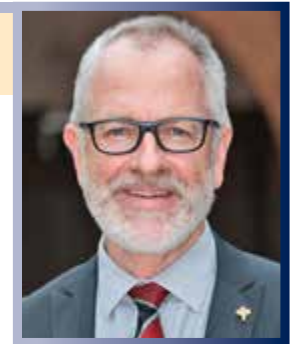
Darrell Caister

(ex officio - Head: Prep)

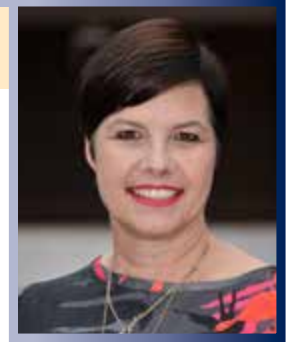
