## From the Chairman

This report covers the 2016 Financial Year and includes extracts from the audited Annual Financial Statements for the year ended 31 December 2016.

As is customary, to provide you with assurance on how the Trustees collectively manage the Foundation's income and capital, I begin my report with the core objectives of the Foundation:

## The main object is to receive donations from third parties for the purpose of:

- applying such funds for education and development at the School; and
- the provision of support services to, or the promotion of, the common interests of the School.

Furthermore, the Foundation may provide funding and support services in the furtherance of the main object of the Foundation for other purposes such as:

- the provision of related and associated education and development courses in relation to academic enrichment, academic support, supplementary tuition or outreach programmes for the disadvantaged and the provision of scholarships, bursaries and awards for study programmes, research and teaching;
- to erect or contribute to the cost of erection of any buildings required for or incidental to the promotion of the purpose and objectives of the Foundation;
- to supplement the salaries of any existing or future teachers at the School; and
- to initiate and participate in fundraising ventures to raise funds to promote the objects of the Foundation

#### Other key subsets of the objects include:

 securing long-term, sustainable funding for the School;

- raising the capital required to support bursary and development programmes from the income derived from such capital; and
- promoting meaningful transformation within the School.

Central to these objectives is ensuring that the St David's boys receive a balanced education which is grounded in the Marist philosophy and to maintain the standards and promote the diversity required in South Africa.

## The Foundation's cumulative efforts over a ten-year period to date are presented below:

- Donations received: R15.6 million;
- Committed pledges to be received: R1.4 million:
- Dividends and interest received, less expenses: R4.9 million:
- Realised and unrealised gains on investments: R11.3 million;
- Awards made: R9.3 million.
- Net capital as at 31 December 2016: R22.5 million.

### The year under review

2016 was a much improved year from a capital markets performance perspective. The growth in the investment portfolio of the Foundation was 9.2% (2015: 3.4%). As at the end of 2016, the allocation of the funds under management was 80.6% (2015: 72.3%) in listed equities and the balance of 19.4% (2015: 27.7%) in cash and cash equivalents. The Trustees have met with Centaur Asset Management, to understand and assess the investment strategy for the investment portfolio and will continue regular engagement in this regard, to ensure that the funds are being managed in a judicious manner.

The Foundation's investment strategy remains consistent: capital growth in excess of inflation with a view to making annual awards of 4% - 6% of opening capital to qualifying programmes and those specifically requested by our donors.

#### In review of our activities in the 2016 year:

- The Foundation's fundraising efforts raised a total of R1 317 482 (2015: R1 456 239), being approximately 6.3% (2015: 7.1%) of the opening capital at the beginning of the year.
- The net gains from its investment activities, net of expenses, amounted to R1 059 800 (2015: loss of R 527 000).
- Awards paid to the school amounted to R1 527 506 (2015: R1 121 697) being 7.3% (2015: 5.5%) of the capital at the beginning of the year. Total awards granted were in excess of the 6% of opening capital guideline as

- a consequence of certain specific donations received during the year, made with the purpose that they be awarded immediately towards bursaries. If these specific donations are excluded the awards fall in line with the 4% 6% of opening capital guidelines.
- The Foundation's capital, after expenses and awards to the school, increased by 7.7% (2015: 2.7%) to R22 518 787 (2015: R20 867 298) as at 31 December 2016.

The School continues to cover the majority of the operational expenses of the Foundation office, due to the benefit derived by the School from the Foundation. However, the Foundation's resolve is to become sustainable without financial support from the School for operational costs. Reasons for this include the intention to remove this particular cost burden from the School and that, particularly when approaching overseas organisations for donor funding, certain of these organisations insist on having operational costs included in any funding proposal as they recognise that an organisation of the Foundation's nature should become sustainable on an independent basis. It remains our objective that 100% of donor funding will always go to the purposes intended, with operational costs being covered only by specifically-allocated portions of grants, interest and dividends.

2016 was a year of double celebration with it not only being the School's 75th Jubilee but also the 10th Anniversary of the St David's Marist Foundation. Memorable events during this year included the St David's Opening of the Market at the JSE on

Thursday 3 March (St David's became the first School in South Africa to open the market and the St David's Marist Foundation 'Business in Education' B-BBEE initiative was launched at this event), the official Jubilee Week celebrations (from 4 – 12 June), the introduction of the celebration of Montagne Day on Friday 28 October, as part of which St David's boys pledged R75 each in support of a Foundation bursary and the Foundation's Donor Cocktail Event on 4 November to which donors past and present were invited and where outgoing Foundation Chairman Mr Robin Smith was honoured.

The Foundation continues to work closely with the Old Boys' Association in assisting it with improving and growing the Alma Mater database and the 2016 75th Jubilee Celebrations offered a wonderful opportunity to welcome back many years of Old Boys, going back as far as 1946. We particularly acknowledge the efforts of Mr Willy Castle, Chairman of the Old Boys' Association, for his ongoing work in bringing together and building a strong and connected Old Boys' base.

We welcomed Mr Simon Denny and Mr John Chemaly (in his ex-officio capacity as Chairman of the St David's Marist Inanda Board of Governors) as Trustees this year and our grateful thanks are extended to Mr Robin Smith who stepped down as Chairman and retired from office during the year, after nine years as a Trustee. Robin has been a stalwart in furthering the objectives and sustainability of the Foundation since its inception, and consequent to his commitment and perseverance the lives of many boys have been positively influenced through Foundation support.

Dr Mark Bussin (outgoing Chairman of the Board of Governors), also retired from office during the year, and we are grateful for his strategic contributions during his tenure.

### Looking ahead

The goal of the Foundation is to be able to increase the number of boys that are fully supported on bursaries at St David's. During 2016 a total of fourteen boys (including one at a tertiary institution, studying to become a teacher) enjoyed the financial support of the Foundation.

We were extremely proud to have another Foundation Bursary recipient matriculate at the end of 2016. This young man, in addition to achieving his General Honours after receiving Colours in Leadership, Music, Drama and Service, matriculated with 5 distinctions.

In addition to providing academic support, the Foundation also seeks to raise funds in support of specific capital development projects. The main project that is being managed under the auspices of the Foundation is a multi-purpose building (the 'Maristonian') which will include a 'home' for our Old Boys and a multi-purpose facility for the School. The requisite approvals for this project are in place, and awareness campaigns and fundraising have commenced.

The 75th Jubilee Circles of Friendship Campaign was the major initiative for the Foundation during the course of 2016, and one which will continue up



until the school's 80th birthday. This Foundation initiative has received prominence at school functions and in various communication media. The message of a broader donor base and a manageable, sustained giving plan over a longer period, continues to be communicated to parents, Old Boys and other stakeholders and by the end of 2016 there were 50 Circles in place.

The Foundation Office has adopted a multifaceted plan and approach to the concepts of giving and philanthropy. There are short, medium and long-term programmes and strategies in place, and these are gaining traction as the awareness of the Foundation increases. These specific programmes were rolled out in 2016 and continue as we advance towards the 2017 Bicentenary Celebration of 200 Years of Marist Education, the St David's 80th Jubilee, and beyond.

For the forthcoming year (2017), the Foundation has resolved to award an amount of approximately R1 383 131 (2016: R1 527 506, including a Capital Development transfer of R204 862) to the School for bursary awards.

It is becoming increasingly evident that St David's is on a significant infrastructural development path, to support the growth in enrolment of families who prefer a Marist education for their boys, adapt to the challenges of becoming an 'innercity' school and advance its role in our broader society of educating boys from a diverse range of backgrounds, including preparing boys from previously-disadvantaged environments for leadership roles in our society. The Foundation

recognises its role in facilitating these initiatives in a productive manner that will not compromise its objectives, nor put at risk its ability to maintain and increase bursary support to deserving boys, while managing the resources under its stewardship in thoroughly-considered processes.

The capital target of R25 million originally set for the Foundation over a decade ago, has been surpassed in terms of cumulative income before considering donations to the School, and we are now on the brink of achieving that sum as net capital within the Foundation. Given, the nature of the aforementioned challenges being faced by the School, this target continues to move upwards, to ensure sustainability of the support provided to St David's and the Foundations beneficiaries, and we are assessing and changing our fundraising models accordingly.

The Foundation could not exist without the support of its donors. I extend deep gratitude on behalf of the Trustees and the School for all the pledges, donations, bequests and other contributions made by donors, past and present. This generosity, in socially and economically challenging times in South Africa, is much appreciated. I also make special mention of the contributions made by the Trustees, Lara Klement (Advancement Manager) and Fiona Budd (Foundation Manager). We have witnessed a continued increase in the level of professionalism in the manner in which the Foundation's affairs are being conducted which we believe will be beneficial to our fundraising efforts in the future. Mr Brian Kalil continues to be of great assistance in his role

as the pro-bono auditor of the Foundation.

To the School's Executive and Board of Governors, the Marist Schools' Council, the Advancement Office, the Marist Old Boys' Association and the Trustees, a special word of gratitude for your continued support. At the time of writing, it is pleasing to note that the first half of 2017 has yielded many positive achievements for the school in general and the Foundation in particular, and it is my sincere hope that the next Foundation Annual Report will be filled with positive achievements in 2017 and healthy prospects in the years that follow.

## Coming Home

Our 75th Jubilee Year was a year of celebration and commemoration, of reflecting on where we have come from and where we are going, of new traditions being established and old friendships being renewed. It was indeed a significant and special year in the history of St David's Marist Inanda.

We live in a world that is changing faster than we can comprehend, in which boundaries and borders are being broken down and yet others built up, through social media, we are 'friends' with people we have never met and the virtual world is now as real and relevant as bricks and mortar. Trust is fragile

However, more importantly is how we continue to imbue and nurture a set of values that will help them navigate any environment or situation in a manner that will mark them as outstanding, as authentic and character-filled. Many Old Boys returning to St David's during our Jubilee year, some for the first time since matriculating, were astounded at the progress that the school has made over the intervening years, how it has grown and developed. However, for many, what was most remarkable was what had not changed: the Marist character

of the school! These men were able to recognise in our current boys that which they have held sacred and which has continued to shape their own lives. This affirmation from these men was an important reminder that although the world does change, our Marist values remain timeless and unopposable. It is to these values that our boys, young and old 'come home' to throughout their lives.

The St David's Marist Foundation, which also celebrated its tenth anniversary in 2016, plays an increasingly important role in ensuring the long-term sustainability of St David's Marist Inanda and in doing so sustaining the Marist values and vision. This task is increasing difficult in a country that has so many needs and in which people are increasingly financially strained. However, we continue to grow our Endowment Fund and support our Bursary and other funds through our generous community of donors who recognise the need to invest in these values and to maintain and develop that which underpins them.

The greatest testament to our donors and their commitment lives in the boys who are supported through our Bursary Fund. To see our boys, who without this financial support would not have had the opportunity to attend St David's, embrace the

opportunities presented and thrive under the care of their teachers, coaches and mentors is both humbling and motivating for all involved in the St David's Marist Foundation.

Our Circles of Friendship initiative, launched in the Jubilee year, has enjoyed some wonderful success in bringing members of our community together around something that they feel particularly passionate about at St David's, be it a sport, cultural activity or education in general. It has been wonderful to meet members of our community at the Coffee and Doughnut mornings and share our ideas and dreams for the school and the role of the Foundation in achieving these. The strength of St David's has always been its strong relationships and the Circles of Friendship initiative has further strengthened the relationships between individuals and between these individuals and the school.

The launch of our Business in Education Fund at the JSE in March 2016 was a pivotal moment for the Foundation. In hosting this event, St David's Marist Inanda and the St David's Marist Foundation made a strong statement to the business community: strengthening the symbiotic relationship between business and education is vital to the progress and transformation of our country. We invited business to engage with us on the issues and challenges facing both business and education and encouraged them to invest in education as a way of meeting these needs. This is an ongoing conversation and we look forward to growing this interdependent relationship with our business community.

The Foundation was intrinsically involved in many events of the Jubilee year and we hope that you will enjoy reading about these in the "A year of celebration".

We hope and trust that walking through the gates of St David's Marist Inanda will always feel like 'coming home' for our boys and their families and we, as the St David's Marist Foundation, are committed to ensuring this by investing in the sustainability of all that St David's stands for. We thank each person,

family and organisation that has donated to the St David's Marist Foundation to make this possible.

## A Year of Celebration

The St David's Marist Inanda Foundation is a registered Trust (No: IT4826/06) and PBO (No: 930023385) and was founded in 2006 to ensure the long-term sustainability of St David's Marist Inanda. In 2016, in addition to the 75th Jubilee Celebrations, the Foundation celebrated its tenth year of existence.

The Foundation, based on the Advancement model used successfully in many overseas schools, as well as local and international universities, has as its primary aim the identification of opportunities for growth and development for St David's. This also includes full engagement with community and society in general in order to support St David's vision, mission and strategic objectives and to benefit those engaged with.

In the immediate term the Foundation has the responsibility to ensure that children from financially disempowered communities also have the opportunity of a St David's education, and to share in the Marist vision. The Foundation administers funds and donations received in support of this aim and supports the holistic development of each bursary beneficiary.

St David's, at its Marist core, has a very strong social development ethos and finding ways to maximise our impact in society remains a priority. The Foundation's focus also centres on introducing and growing philanthropic thought, practices and technology within our community – to do 'What you can, with what you have, where you are."

## Foundation Bursary Beneficiaries

There are currently 44 boys on bursaries at St David's – 15 (14 at school level and 1 in tertiary, studying teaching) boys are funded directly through the Foundation, and a further 29 are funded through the School, some in partnership with the Alexandra Education Trust and the Student Sponsorship Programme.

Donor funding received during 2016 has gone a long way to making a very real difference in the lives of boys who would otherwise be unable to afford a Marist education and has assisted us practically in living out our Founder, St Marcellin Champagnat's belief that, 'To teach children, you must love them and love them equally.'

### **Circles of Friendship**

The 75th Jubilee Circles of Friendship campaign was designed to link the parents, staff, boys, and Old Boys as a community in long-term relationship and giving a campaign, to commemorate the 75th Jubilee year and carry through to the school's 80th birthday.

The aim of the Circle ampaign is to connect the entire St David's community through interlinked circles of giving reflecting all the areas of connectedness and involvement at St David's; the Montagne Day Pledge was the start of initiating the boys' Circles of Friendship which will continue until their Matric Year and beyond as they become Old Boys.

The Campaign was initially introduced towards the end of 2015 when the entire School received the Circles of Friendship Bracelet with an accompanying explanation, the campaign was promoted through various forums and mediums to parent, staff and Old Boys throughout 2016 (including through the Coffee and Donuts Sessions – each of which covered a different area of interest and activity at St David's), with the final 'activation' being with the St David's boys through the Montagne Day Pledge initiative. A google form link

was also shared with the community where Circles could register and indicate their area of support and how they would be contributing to their Circle (ranging from monthly to annual contributions or contributions on an ad hoc basis if they had decided to engage in fundraising activities in support of their Circle). The St David's Marist Foundation Trustees initiated the first Circle and by the end of 2016 there were 50 Circles in place, which to date had brought in combined donations of R 754 236.

## Coffee and Doughnut 75th Jubilee Circles of Friendship Mornings

Seven Coffee and Doughnut mornings were held during the year to provide further information on the Circles initiative, each with a specific focus, for example, Sports and Cultural Activities, Outreach, Old Boys, etc. A number of Circles were initiated through these mornings, with some being more 'fundraising' focused than others.

The mornings were a wonderful opportunity for some great discussions around areas that parents feel passionately about and ideas on how to raise funds through the various Circles, from those

Circles who preferred this rather than to commit to a monthly or annual donation, has been very innovative and inspiring. The idea of the Circles is to create a form of Giving Circle participatory philanthropy linking our community in a rich tapestry of support and connection and we have been inspired and touched by the way this initiative has evolved.

## St David's JSE Opening of the Market Morning (3 March 2016)

#### **'Business in Education' BEE Bursary Fund initiative**

On Thursday 3 March, St David's became the first School in South Africa to open the JSE (Johannesburg Securities Exchange) trading floor for the day as part of the launch of the St David's Marist Foundation 'Business in Education' Bursary Fund initiative.

Almost 100 Captains of Industry, including several St David's Old Boys, gathered at the JSE for the launch - Nicky Newton-King, CEO of the JSE, gave the Keynote Speech and commended St David's on being the first school in the history of the JSE to open the Market. Andy Hall, then Vice-Chair of the

St David's Marist Foundation, and CEO of Adcock Ingram, introduced the 'Business in Education' initiative and invited business to partner with St David's to invest in education with a school that has a proud 75-year legacy of creating leaders who act with integrity, have a hunger for pursuing excellence and social responsibility and are values-driven business, political, sports and community leaders.

Sandra Borrageiro, Head of Project Delivery, Trading and Market Services at the JSE, and a proud St David's parent. MC'd the morning and the St David's Chamber Choir and Saxophone Quartet entertained the gathered guests with their performances, under the direction of Mr Ferreira and Mr Luke. Members of the Matric Executive and the St David's PR Portfolio were also in attendance with 2016 Head Boy Joshua Clegg, and Deputy-Head Boy Bogosi Msutwana. joining Mike Thiel, Andy Hall, Fiona Budd and Lara Klement on the JSE rostrum to officially open the Market with the sound of a Kudu Horn, drums. marimba and vuvuzela. The gathered guests were also involved in the count-down to the Market Open at 9am and the JSE commented that St David's had provided the loudest Market Open to date at the JSE.

Nicky Newton-King had earlier light-heartedly remarked in her speech that at the JSE they have noticed a correlation between the amount of sound made by a company opening the Market, and the (good) performance of the Market that day – that night business news reports were reporting an unprecedented good day on the JSE Market!

The morning closed with the St David's boys giving an impromptu presentation of 'Inanda's Call' which made a marked impression on the guests.

St David's was also delighted to be able to livestream the event from the JSE – members of the St David's community were able to watch the proceedings live back at St David's, and around the world.

The 'Business in Education' initiative invites businesses to partner with St David's in establishing a fund, ring-fenced according to the B-BBEE Revised Codes of Good Practice, which will enable the school to expand its existing bursary programme which awards young deserving scholars from historically disadvantaged backgrounds with bursaries to St David's.

As Mike Thiel, Executive Headmaster, said "The issues faced by business and society are issues that should be solved during the formative educational years. Our strategic partnerships with Business are creating opportunities to grow a truly transformed and uplifted South Africa. Business and Education

share a common dialogue - our partnerships with Business will bring this conversation into one space."

## Willy Castle Triple Marathons Bursary Campaign

(February - April 2016)

It was a Triple Marathon Year for St David's legend Willy Castle during the St David's 75th Jubilee Year. Willy ran three Marathons in three months in support of two of the Foundation Bursary Fund programmes: his 14th Two Oceans Marathon on Saturday 26 March, his 4th London Marathon on Sunday 24 April and his 29th Comrades Marathon on Sunday 29 May. Willy ran the three Marathons in aid of the Willy & Dorothy Castle Sports and Cultural Fund, as well as in aid of the Marist Old Boys' Bursary Fund - a fund which supports boys who are sons of St David's Old Boys, who may have fallen upon difficult times, or any boy that the Old Boys identify as being a worthy candidate and who displays the Marist values. He was unfortunately unable to complete the Two Oceans Marathon due to suspected hypothermia, but successfully completed his 4th London Marathon and his 29th Comrades Marathon and in the process raised R71 842 for the two bursary funds.

## Montagne Day 2016 Pledges

(28 October 2016)

The 75th Jubilee year celebrations formally concluded with the celebration of Montagne Day Mass on Friday 28 October which marked the 200th Anniversary of the visit of St Marcellin Champagnat to the bedside of the dving 16 year-old Jean-Baptiste Montagne, an incident which profoundly affected St Marcellin and inspired him to found the teaching order of the Marist Brothers. Each boy was asked to make a Montagne Day Marist Pledge, and to accompany this by donating R75 towards the 75th Jubilee Circles of Friendship Campaign, raised through his own efforts and acts of service. These donations form the start of each year group's own Jubilee Circles of Friendship as per the Matric Years that they will eventually become, for example, those boys who were in Grade 6 in 2016 will be the Matric Class of 2022. The funds raised go towards a bursary for an underprivileged boy (a modern-day Montagne) - the Grade 5s, led by Mr Byron King, decided to take part in the 94.7 Mountain Bike Challenge on 13 November 2016 to raise additional funds in support of their Montagne Day Pledges towards this bursary and contributed just over R21 000 to the final tally of R70 650 in pledges received.

## 75th Jubilee Photo Montage of St Marcellin Champagnat

As part of the Montage Day Mass the photo composite of St Marcellin Champagnat was unveiled and blessed - the idea for this had come about in the Foundation office whilst conducting on-line research for the Circles of Friendship campaign and Jubilee Bracelet - we came across a photo composite of St Marcellin Champagnat that had been created by Marist High School in Chicago, USA. The face of St Marcellin was made up of photographs of the students and staff of the Marist High School and we felt that this would be an excellent way to celebrate and remember our 75th Jubilee Year for many years to come and to reflect the Circles of Friendship that were formed at this time. To have the face of our Founder made up of all of our faces reflects where our Marist roots come from and how we, as the St David's community. continue to carry forward the ethos, vision, work and legacy of St Marcelllin Champagnat 200 years after he founded the Marist Brothers teaching order. The Chicago photograph was used on the information cards that accompanied the Jubilee Bracelets and. being fortunate to have the photographic talents of Mr Reddiar at St David's, we spoke to him about

creating our very own St David's image. He worked throughout the Jubilee Year to compile the photo montage from individual St David's boys and staff photographs plus photos taken at the Jubilee celebrations and other events through the year. The Photo Montage has been placed in the foyer of the Champagnat Hall in commemoration of our 75th Jubilee Year.

Montagne Day also formally led into the Bicentenary of the founding of the Marist Institute as well as marking the 150th year of Marist education in South Africa, which are both celebrated in 2017. The Marist Bicentenary will be celebrated globally throughout the Marist community.

### **Staff Giving Fund (SGF)**

The Staff Giving Fund (formerly known as the Staff Bursary Fund) was established 18 years ago in response to the needs of boys in the School and in keeping with one of the teachings of St Marcellin Champagnat that "to teach children well, you must first love them, and love them all equally." The Fund provides boys on financial support with not only the basics such as textbooks, uniforms and lunches but also some of the extras that would enable them to thrive such as proper sports kits, payment for extracurricular tours, tutoring and medical expenses

(such as glasses and dentistry), meaning that they have access to support and opportunities equal to those of their more financially-privileged peers at St David's.

The SGF is supported solely by the monthly contributions of St David's Staff and from the fundraising activities from Champagnat Day (6 June each year). The funds are administered by the St David's Marist Foundation however the SGF Committee, headed by Mrs Belinda Marais, make the decisions around the allocation of the funds. During 2016 48 staff members contributed a total of R73 100 via their monthly contributions bringing the total donated over the past 18 years to just under R900 000.

## Christmas Giving Campaign 2016

#### (November 2016)

2016 concluded with the third annual Christmas Giving Campaign - an initiative through which donors give a Christmas gift of a different kind - one which will have the most profound impact on the lives of young boys who ordinarily would not have access to the unique opportunity of a Marist education, due to family or social circumstances.

Donations of R18 400 were received which were highly appreciated in light of the fact that the campaign last year ran alongside the 2016 Montagne Day Pledge initiative (which brought in funds of R70 550). Total contributions to the Christmas Giving campaign over the past three years have amounted to R194 000.

## A Tribute to Robin Smith (Outgoing Foundation Chairman)

It is with gratitude that we acknowledge the contribution made to the Foundation by Mr Robin Smith who stepped down as Chairman after 5 years of dedicated service in this role, and 9 years in total as a trustee. Robin's leadership and passion have driven the Foundation forward during challenging economic times and some considerable milestones have been reached during his time as Chairman. Robin and his wife, Alison, were acknowledged and thanked at a small but significant donor appreciation evening held in November and incoming Chairman, Andy Hall, welcomed into the seat.

### In Conclusion

The St David's Marist Foundation continues to make strides in achieving its vison and objectives - to have an impact on the lives of the boys it supports and on St David's Marist Inanda as a whole.

This impact, however, is only possible as a results of the many donors (including individuals, companies and foundations) that align themselves with our vision and give generously to our cause. We thank our donors and donors- in-kind most sincerely for all of your support during 2016 – 1 224 individual donations totaling R1 317 482 were received which is a phenomenal contribution.







\*Centaur Asset Management have been mandated to invest monies on behalf of the Foundation with a view to long term out performance (of JSE listed equities) and an annual liquidity need of 4-6% of the gross capital, under management, at the beginning of each year.

The Foundation's asset manager, Centaur Asset management, led by Roger Williams, reported an Internal Rate of Return of 9%, (2015: 3%) for assets under its management. The Trustees reviewed the investment strategies and performance of these activities during the year and were satisfied that these remain in line with the Foundation's investment plans.

Centaur's strategy is an absolute return strategy with a view to outperformance of the South African equity market as a whole. We are satisfied with the performance of Centaur over the last few years and consider that the mandate has been achieved. We endorse the strategy for the coming year with a high equity weighting and believe that the Foundation's planned liquidity needs are sufficiently catered for.



## Funding Programmes

The Foundation can receive both restricted and unrestricted donations. **Unrestricted donations** are spent at the discretion of the trustees for the purposes that conform to the mission of the School: this provides important flexibility to the trustees and the School Executive. **Restricted donations meet** the specific aims of donors who may wish to direct their giving at other projects or objectives.

A taxpayer making a bona fide donation in cash or kind to the Foundation (an organisation approved in terms of Section 18A of the Income Tax Act 58 of 1962) is entitled to a deduction from their taxable income of the amount donated and the Foundation issues the donor with a tax certificate entitling the donor to claim the donated amount as a deduction (up to 10% of taxable income).

### **Bursary Funds**

#### **Father Bernard Brewer S. J Bursary**

The Father Bernard Brewer S. J Bursary enables St David's to support deserving boys with academic potential from a previously disadvantaged background.

#### **Paul Edey Educators Bursary**

The Paul Edey Educators Bursary enables St David's to make its contribution to teacher development in South Africa by supporting candidates through the school's Teacher Learnership Programme.

#### Willy & Dorothy Castle Extramural Bursary

The Willy & Dorothy Castle Extramural Bursary is awarded to boys who show promise in the areas of sport or culturals whilst being able to maintain the required academic standard.

#### **Tertiary Education Bursary**

The Tertiary Education Bursary is a grant that is awarded to matric candidates with potential, to further their studies at a tertiary institution of their choice in South Africa, primarily in the field of Education.

#### **Old Boys' Bursary Fund**

The St David's Marist Old Boys' Bursary is a grant that is awarded by the Marist Old Boys' Association either to the son of an Alumnus or to a candidate identified by the Association.

#### **Staff Giving Fund**

The Staff Giving Fund currently assists numerous learners with support for uniforms, books, the payment of school tours, and other incidental costs.

#### **UK Old Boys' Fund**

The UK Old Boys' Fund supports the endeavours of the Foundation by funding bursaries, scholarships and projects as identified by the St David's Marist Foundation UK Charity Trustees.

## Project, Facilities & Development Funds

The Foundation seeks to provide St David's with funding support for development of the School campus facilities to enhance and support curriculum activities and enable students to experience an education at the highest level, through the following five funds:

#### **Capital Development**

Provides funding support for the development of the School campus facilities to enhance and support curriculum and extra-curriculum activities and enable students to experience an education at the highest level.

#### **Leadership Development**

Provides funding support for programmes and projects to assist in developing the leadership potential and ability of students to the highest level.

#### **Cultural Development**

Provides funding support for programmes and projects to assist in developing and growing the cultural activity potential and ability of students to the highest level

#### **Sports Development**

Provides funding support for programmes and projects to assist in developing and growing the sporting potential and ability of students to the highest level.

#### **Community Development**

St David's is currently involved in over twenty-four community involvement and service projects across

the Preparatory and High School. Programmes include educational support and enrichment, sports development, feeding programmes, project visits and financial and resource donations. The projects are all very hands-on with St David's boys being expected to actively initiate, lead, participate in and commit to programmes and projects. Project selections are guided by the Key Strategic Drivers (KSDs) that underpin all activities that take place at St David's.

## The Marist Legacy (Bequests)

This Fund allows donors to plan their giving to the Foundation through their wills. The impact of a bequest reaches far into the future and beyond a lifetime.

## The Business in Education Bursary Fund Initiative

The introduction of the Revised Broad Based Black Empowerment Codes of Good Practice has created various opportunities through which corporate funders can benefit when making contributions to the St David's Marist Foundation.

The Business in Education Fund was created to enable enterprises to partner with the Foundation in realising measurable and quality education intervention programmes through full bursaries to St David's for identified learners from historically disadvantaged backgrounds.

The Foundation has both the structure and the strategic approach through which to successfully engage enterprise in this arena and was specifically designed to allow for the separate accounting and reporting process required by the B-BBEE Codes, to give corporate funders maximum scoring benefit.

#### (ex officio - Advancement Manager)


