## FROM THE CHAIRMAN

*This report covers the 2021 Financial Year and includes extracts from the audited Annual Financial Statements for the year ended 31 December 2021.*

It is my pleasure to introduce the St David's Marist Foundation's 2021 Annual Report to you. I begin my report with a reminder of the core objectives of the Foundation, to provide you with assurance on how the Trustees collectively manage the Foundation's income and capital.

- **The main object of the Foundation is to receive donations from third parties for the purpose of:**
  - applying such funds for education and development at the School; and
  - the provision of support services to, or the promotion of, the common interests of the School.
- **Furthermore, the Foundation may provide funding and support services in the furtherance of the main object for other purposes such as:**
  - the provision of related and associated education and development courses in relation to academic enrichment, academic support, supplementary tuition or outreach programmes for the disadvantaged and the provision of scholarships, bursaries and awards for study programmes, research and teaching;

- to erect or contribute to the cost of erection of any buildings required for or incidental to the promotion of the purpose and objectives of the Foundation;
- to supplement the salaries of any existing or future teachers at the School; and
- to initiate and participate in fundraising ventures to raise funds to promote the objects of the Foundation.

### ■ Other key subsets of the objects include:

- securing long-term, sustainable funding for the School;
- raising the capital required to support bursary and development programmes from the income derived from such capital; and
- promoting meaningful transformation within the School.

Central to these objects is ensuring that St David's boys receive a balanced education, grounded in the Marist philosophy, and to maintain the standards and promote the diversity required in South Africa, providing access to and excellence in education.

### ■ The Foundation's cumulative efforts over a fifteen-year period to date are presented below:

- Donations received: R28.3 million (2020: R25.4 million);
- Investment income, after expenses: R10.7 million (2020: R10.0 million);
- Realised and unrealised gains on investments: R19.4 million (2020: R13.1 million); and
- Awards made: R21.7 million (2020: R18.4 million).
- Net capital as at 31 December 2021: R36.8 million (2020: R30.3 million).

## The year under review

*As Trustees we are deeply aware of our responsibility to manage the funds received by the Foundation in a judicious and prudent manner, taking into account the Foundation's commitment to sustainably support current bursary recipients and, if possible, grow bursary awards over time, as well as our duty of care to donors through the manner in which we manage their contributions.*

Our goal remains to realise annual capital growth in excess of inflation, with a view to making annual awards of between 4% - 6% of opening capital to qualifying programmes and bursary recipients. This is in addition to donor-specific bursary funding which is received annually and goes directly to the bursary costs of the relevant recipients each year.

Through the Foundation's investments in the Centaur BCI Flexible Fund (Centaur Fund) and the Momentum Flexible Investment Fund (Momentum Fund) the underlying asset allocation comprises a

diversified spread of South African listed equities, preference shares, offshore investments, cash, bonds and property. Approximately 65% of the Foundation's funds are invested in the Centaur Fund, 32% in the Momentum Fund and the balance in interest-bearing money market deposits.

The events of the past two years could not have been foreseen, and these times have made access to quality education an even greater priority. The Foundation made its largest annual award to date to the School during 2021 in support of 18 College bursaries (with 8 of these including boarding) and 4 tertiary bursaries (3 of these funded through specific donors who have continued their support for their bursary recipients beyond St David's). We were delighted to celebrate the graduation of two of the four tertiary bursary recipients, one receiving his Bachelor of Commerce in Accounting, and the other his Bachelor of Arts in Humanities.

The Mizpah Bursary Fund, founded by one of the 2017 Matric bursary recipients

with R1 000 he had raised through his own efforts, to ensure that future boys in need will be able to receive the same opportunities he did at St David's, through donations and investment income, had grown to R102 642 (2020: R83 086) by the end of 2021.

### *In reviewing the Foundation's activities in 2021 the following is worth mentioning:*

- The Foundation's fund-raising efforts raised a total of R2 634 782 (2020: R2 633 736). These included donor-specific awards of R1 451 222. In a year when the financial circumstances of many in our donor community was under pressure, this was a remarkable achievement.
- The gain from investment activities before interest and dividends, net of expenses, amounted to R6 425 420 (2020: R777 863). The total growth in the investment portfolio of the Foundation of 21.4% (2020:8%), being capital growth plus interest and dividends, was an excellent recovery in the wake of the

battering the markets took in 2020, due to the impact of the global pandemic.

- Awards paid to the School amounted to R3 280 692 (2020: R3 226 829). Excluding donor-specific awards the award made by the Foundation comprised 4.6% (2020: 4.7%) of the Foundation's capital at the beginning of 2021. Including donor-specific awards the award made by the Foundation comprised 10.6% (2020: 10.9%) of the capital at the beginning of the year.
- 22 young men were supported on bursaries in 2021 (2020: 23) and of these bursaries, 8 included the costs of boarding at St David's.
- The Foundation's capital, after expenses and awards to the school, increased by 24% to R36 778 540 as at 31 December 2021 (2020: R30 302 100).

The Foundation's operational expenditure budget for 2021 amounted to R52 511, all of which was utilised in support of fund-raising development and initiatives. The School continues

to cover the majority of the operational expenses of the Foundation office.

In time, the Foundation is resolved to becoming sustainable, without financial support from the School. Reasons for this include the intention to remove this particular cost burden from the School and, more importantly, that certain overseas organisations we approach for funding require operational costs to be included in any funding proposal as they recognise that an organisation of the Foundation's nature should be sustainable on a financially independent basis. It remains our objective that 100% of donor funding will always go to the purposes intended, with operational costs being covered only by specifically-allocated portions of grants, or from interest and dividend income.

The Foundation continues to work closely with the Old Boys' Association in supporting their specific donor funds, managing their invested donor funds and growing the Alumni community.

## Looking ahead

*The goal of the Foundation is to increase the number of boys who are fully supported on bursaries at St David's over time, within our self-imposed constraints and taking into account the turbulent times being experienced in financial markets and cognisant of the educational divide that has been even more exacerbated by the Covid-19 pandemic. During 2021, 22 young men, who would otherwise not have had the benefit of a St David's education, or furthering their tertiary education, were supported by the Foundation.*

The St David's Marist Foundation Office's strategy since 2015 has been to adopt a multi-faceted approach to the concepts of giving and philanthropy. There are short, medium and long-term programmes and strategies in place, and these continue to gain traction as the awareness of the Foundation increases.

For the forthcoming year (2022), the Foundation has resolved to award an amount of R4 112 772 (2020: R3 226 829) to the School specifically for bursary awards. It is evident that the huge generosity of our donors and the tireless work of our Foundation Team is making a material impact in helping to develop some of our society's future leaders.

The Foundation could not exist without the support of our generous donors, a number of whom have shown amazing long-term commitment to our objectives, and year after year continue to recognise the difference they are able to make in giving the precious gift of a Marist education to under-privileged boys. We recognise that every donor's contribution is made in today's immensely challenging economic circumstances, with the added impact of the Covid-19 global pandemic, and balanced against the needs of other worthy causes. I extend very deep gratitude on behalf of the Trustees and the School for all the pledges, donations, bequests and other contributions made by donors over the last year.

I must make special mention of the contributions made by Lara Klement, the School's Head of Advancement, and Fiona Budd, our Foundation Director. Their selfless efforts, innovation and persistence are reflected in the donations received in 2021 of more than R2.6 million – a magnificent achievement.

We thank the Foundation's accountants - Sergio and Vannessa Maraschin and Adri du Plessis of Accvantage Solutions - for the

professional way in which they manage this important function for the Foundation. We extend our sincere condolences to the family of Dave Phillips, the Foundation's auditor for the past two years – Dave very sadly passed away from Covid in June 2021.

To the School's Executive and Board of Governors, the Marist Schools' Council, the Advancement Office, the Marist Old Boys' Association and the St David's Staff, thank you for your continued support of the Foundation, and caring for our boys.

Finally, I thank my fellow Trustees for the time and resources they dedicate to the Foundation. It has been a pleasure to serve alongside each of you. I have received an immense sense of reward seeing the difference that your efforts have made in the lives of the boys we have had the privilege of supporting.

At the time of the release of this report the leadership of our Foundation's Board of Trustees will be in the capable hands of Simon Denny and Tyson Sithole, two highly competent and vibrant young men, both of whom understand what it means to live the Marist ethos. I am confident the Foundation will achieve greater heights as it continues to help develop ethical leaders for our society.

## FROM THE HEAD: ADVANCEMENT 2021

*For many not engaged in philanthropy, the concept often brings to mind the thought of money! And for many, discussions around money, and especially asking for money, are uncomfortable.*

However, for those actively involved in philanthropy, be they donors, fundraisers, programme directors or co-ordinators, grant makers or grant writers, and many others, the thought that is primarily top-of mind is that of impact. Impact on lives, communities, systems, society and ultimately 'the world!' – shifting the status quo in ways that make our world a better place, a kinder place, a more just and equitable place, a safer place, a more human place!

*The word "philanthropy" comes from the Greek language. In the Greek tradition, the word philanthropy grows from the words "philos" meaning "love" and "anthropos" meaning "man" or "humanity." Literally, in the original Greek meaning, the word philanthropy is the "love of humanity."*

We do not, however need to look beyond our own South African context to find an equivalent word that encapsulates the same sentiment, and which shows that the concept of philanthropy is deeply embedded in our African soil.

***Ubuntu is a Nguni term meaning "humanity". It is sometimes translated as "I am because we are" (also "I am because you are"), or "humanity towards others" (Zulu umuntu ngumuntu ngabantu).***

Within St David's Marist Inanda itself, the ethos and values of Marist education are similarly grounded in our particular charism, with our founder, St Marcellin Champagnat stating that "to teach children, we need to love them, and love them all equally." Marist characteristics of Family Spirit, Presence and In Mary's Way require of all of those working and engaging in Marist education to embody the essence of what it means to be truly human.

Two years of the Covid-19 pandemic certainly tested our collective humanity from a global level right down to our interactions on a personal basis. When physical contact with even close family members was restricted and even legislated, where under 'normal' circumstances interactions would have been spontaneous, lighthearted and frequent, we could naturally expect there to be a negative impact on us as humans. And we are certainly seeing the 'aftershocks' of the past two years in many areas of life. We are, in many ways, only now calculating the actual cost and impact on lives, livelihoods and on the human psyche.

So, at critical times like the one we have been through when survival has been the operating mode, where does philanthropy... ubuntu... love... humanity... feature? Does it even feature? And can we reasonably expect people to be concerned about others beyond themselves and their immediate family at such times?

Our experience in the St David's Marist Inanda community and in the St David's Marist Foundation was that the sense of



collective responsibility for each other and especially for those most vulnerable was AMPLIFIED by the crisis. This trend was replicated globally on a macro and micro level, despite headlines in the news about corruption and greed that gave the impression of a selfish, rather than a selfless world. There was an outpouring of concern, love, kindness and compassion ... and indeed, money!

And so, we come back to the point about philanthropy and money. Money is vital to the process of 'doing good', of having an impact, of changing the status quo, of making the world a more equitable place, but it is not the driver! A humanitarian response comes from the heart, often from a deep personal understanding of the connectivity of lives and social systems needing to live in harmony, not in conflict.

We see this understanding and perspective in all of our donors, and we saw how having a humanitarian outlook on life mobilized and motivated this particular group of people to want to do and give more – in recognizing

that they themselves were vulnerable, they recognized that there were others who were even more vulnerable and their already heightened sense of responsibility towards others was triggered to respond to the humanitarian crisis unfolding. This response happened on a global level, but we saw it playing out on a community level at St David's. We saw our Marist ethos and values, ubuntu, philanthropy playing out on a daily basis.

Again, to the money aspect of the conversation –many of the people we speak to about their reasons for giving relate a strong sense of purpose in their lives and in their work, which on a fundamental level all link to issues of social justice. Whilst for some (working in the NPO/ NGO/ charity sector), this work happens on the ground on a daily basis, others are willing and able to fund or support (through donations of resources or time) this work – and all are equally crucial to the success of programmes that aim to create a more equitable society and better world.

Whilst 'changing the world' might seem like an impossible task and even a somewhat 'warm and fuzzy' ideal, this Annual Report will show that the work being done is strategic and focused and is driven by a cohort of people who are skilled and knowledgeable, as much as they are passionate. And whilst the facts and figures tell a significant story about the work being done, the stories of our recipients, our donors, our staff and volunteers show the impact on the lives of people and how change is possible when we connect around the common, human good.

I add my thanks to all who make the work of the St David's Marist Foundation possible, and who stand in solidarity with us in our belief that every child deserves a quality education and to live in a safe and just world.

*2021, following on in the extraordinary and unprecedented wake of 2020, once again required resilience, agility and adaptability. Our St David's family, donors and supporters continued to demonstrate their Marist hearts, giving of their money and time in support of the Foundation, however they could.*

Through their great generosity the Foundation was able to provide funding for 18 St David's College bursaries and 4 tertiary bursaries.

The Foundation had received donations totaling R2 634 781 by the end of 2021 and made a 2021 total award of R3 280 692 to the School in support of bursary funding, development funding and benevolent fund support.

We are delighted to be partnered with the Batho Batho Trust, the Karl Flowers Memorial Trust, the Investec Charitable Trust and the Temba

Bavuma Foundation, demonstrating the power of philanthropic partnerships in bringing about a life-changing impact through access to a quality education.

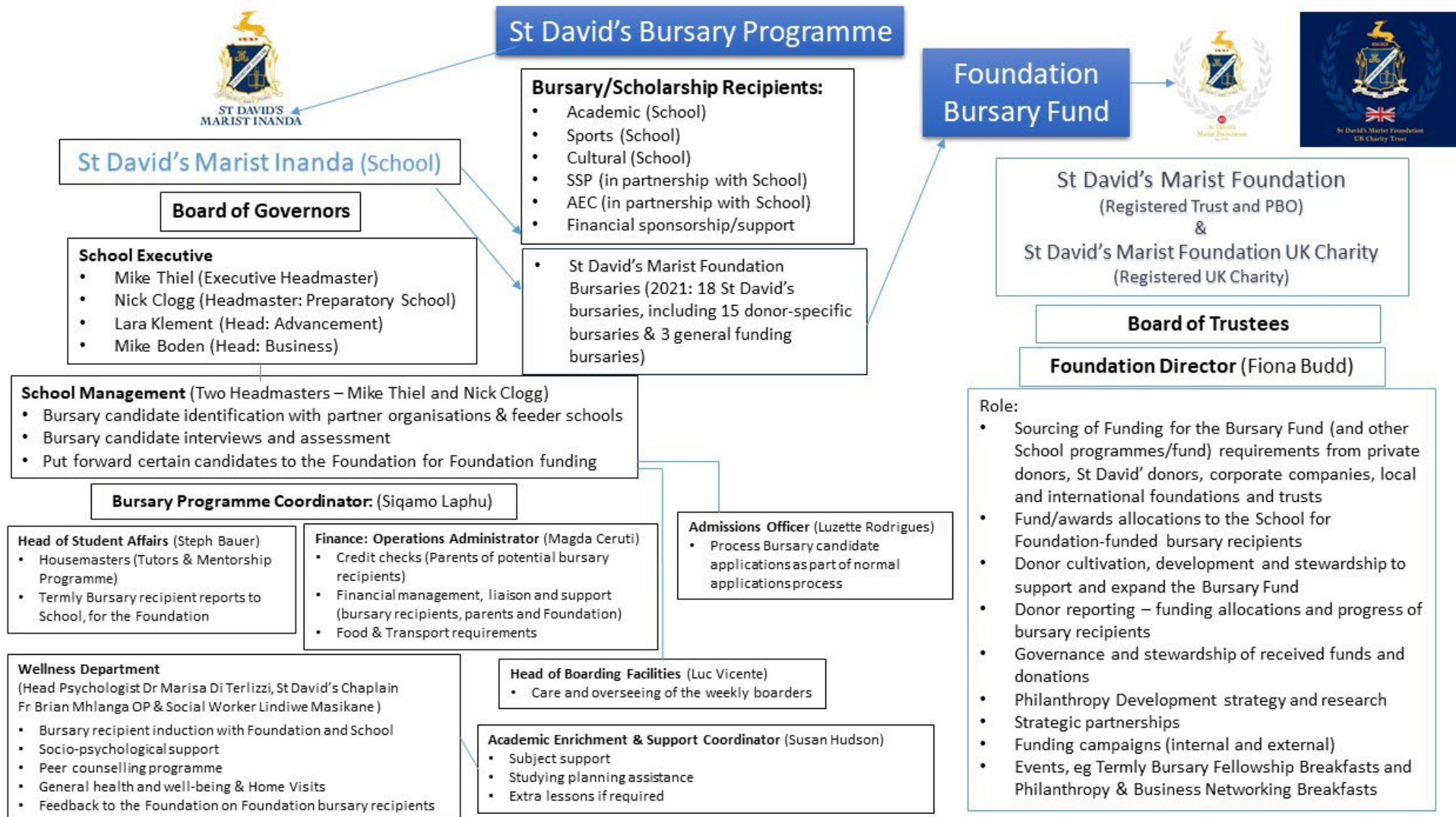

#### Team Marist 'Power of M' Champagnat Day 2021 Run

The first-ever Team Marist Champagnat Day 2021 'virtual' Run, uniting all five of the South African Marist Schools – St David's Marist Inanda, Sacred Heart College and Marist Brothers Linmeyer in Johannesburg, St Henry's Marist College in Durban, and St Joseph's Marist College in

Cape Town – launched on Sunday 6 June (Champagnat Day) and ended on Sunday 20 June. All members of our Marist schools' communities were invited to take part – pupils, parents, staff, alumni – wherever they were in the world. Participants registered for their own school's virtual event and completed their activity of choice in their home neighbourhood, locally or internationally, at any time during the two weeks the event was open. 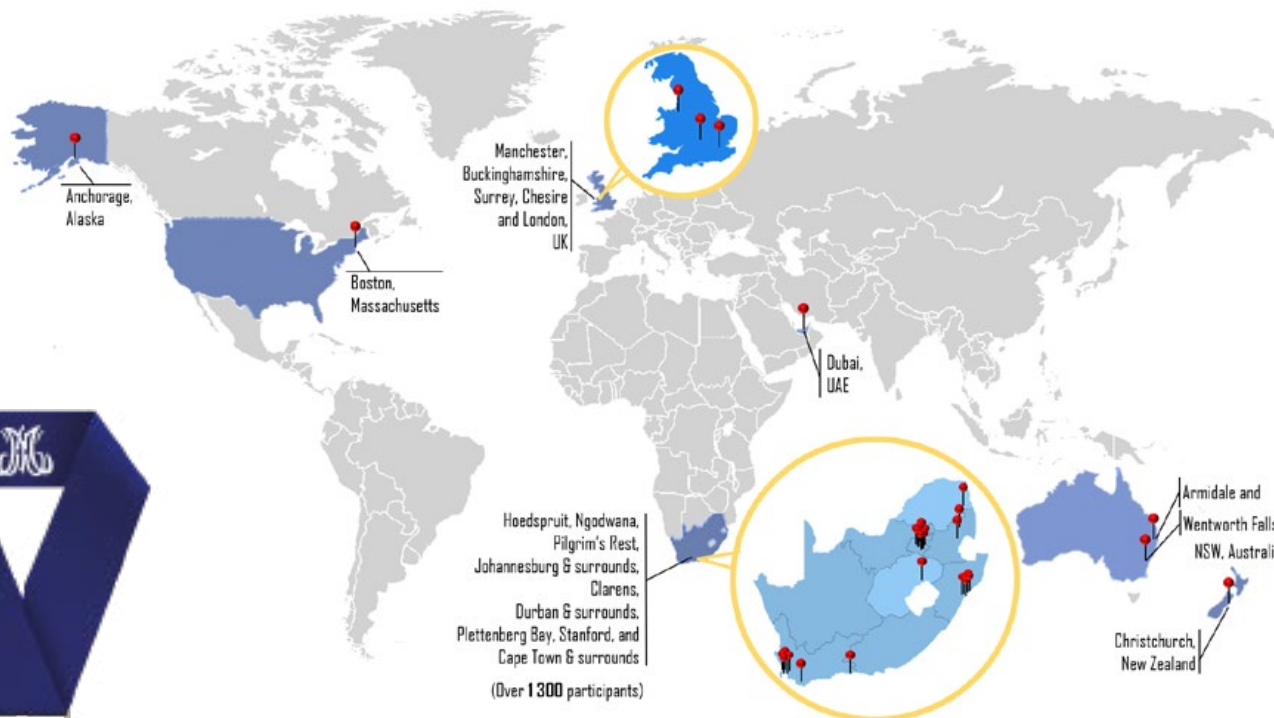
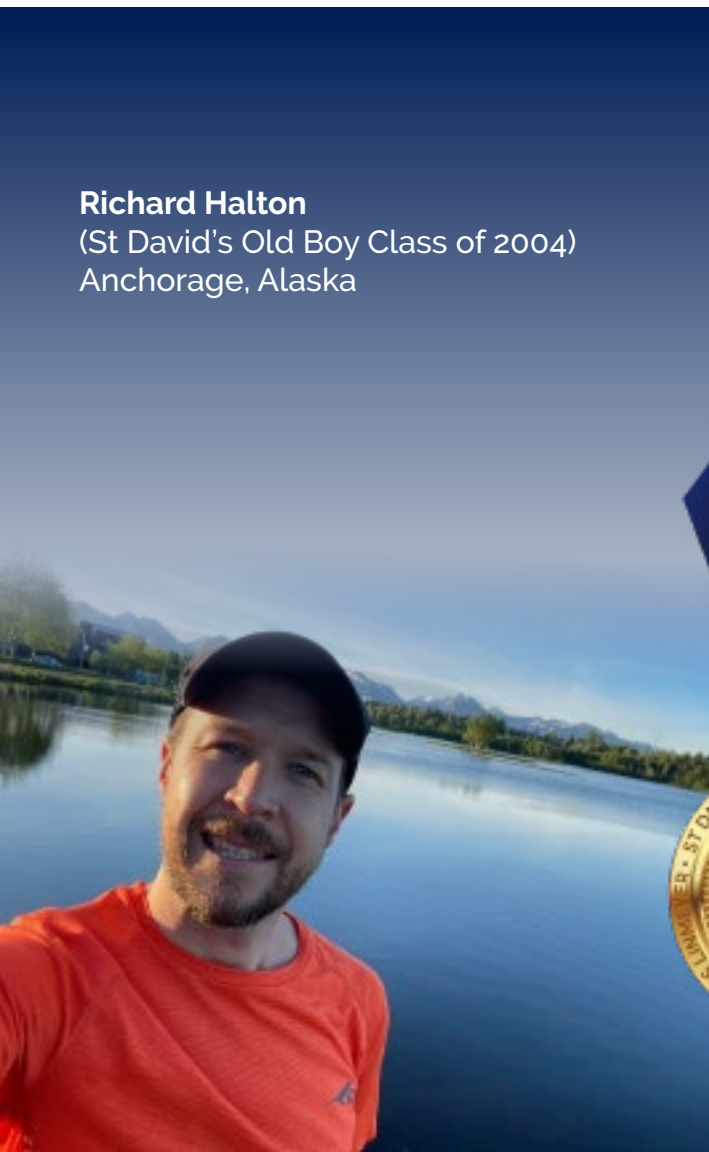

1 322 participants took part, on five continents, running/walking/cycling/canoeing over 5 000 kms and contributing a combined R118 000 through entry fees and donations, to the schools' Champagnat Day Funds, Marist Mercy Care and the Three2Six Programme.

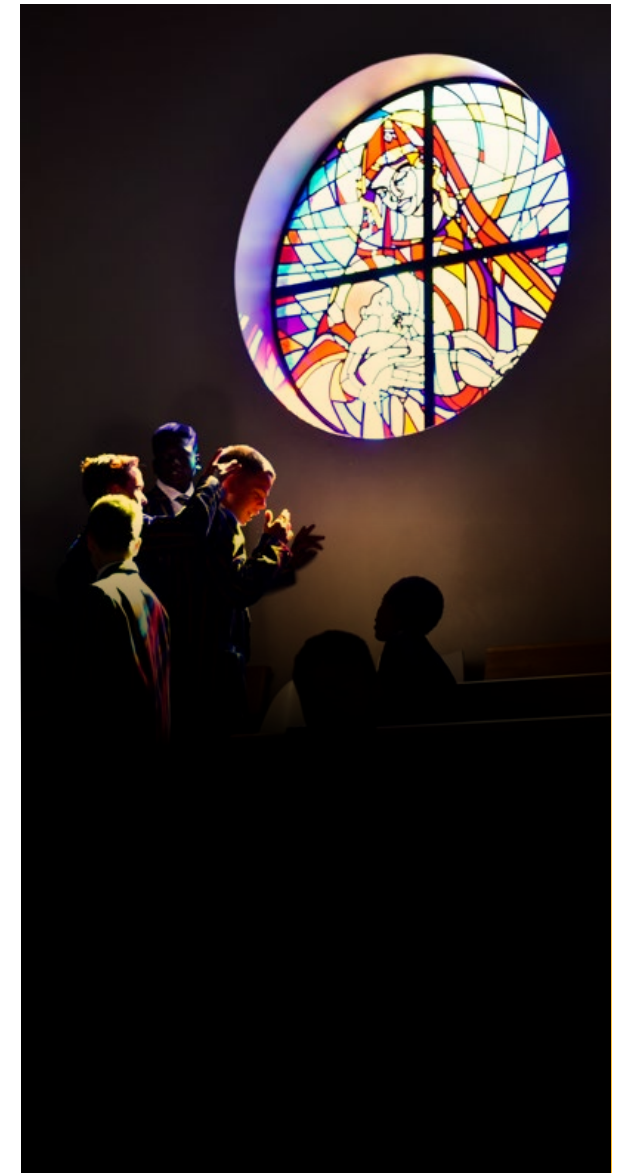

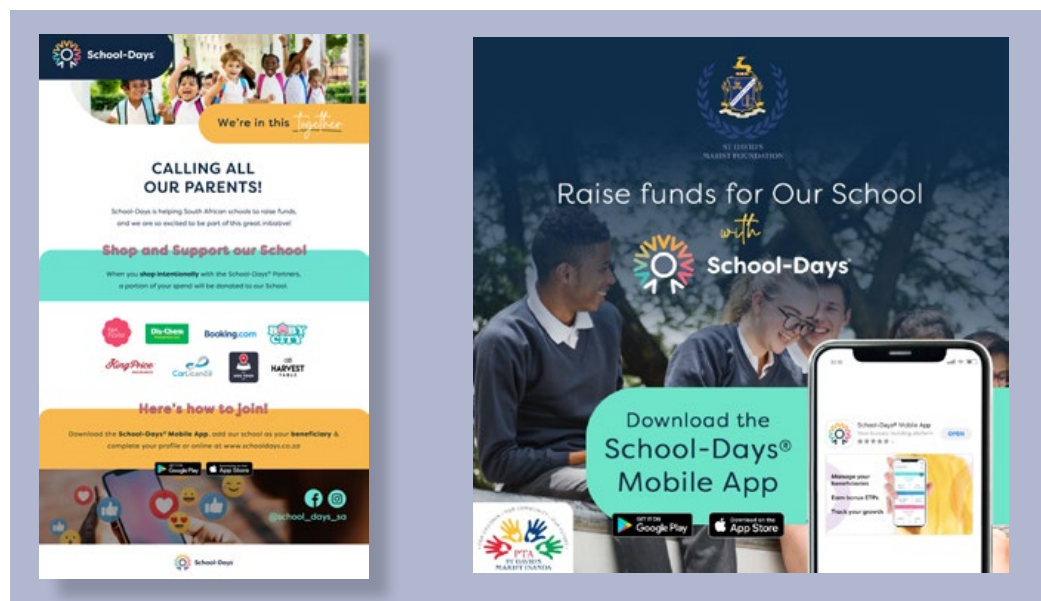

PTA and the Foundation. The School-Days Programme is similar to the My School programme, but with different partner organisations.

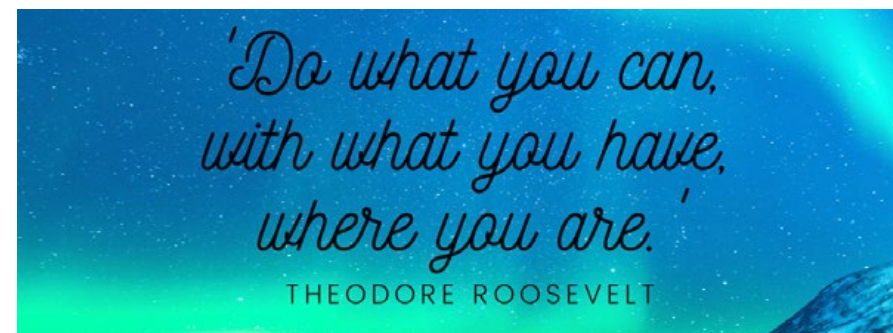

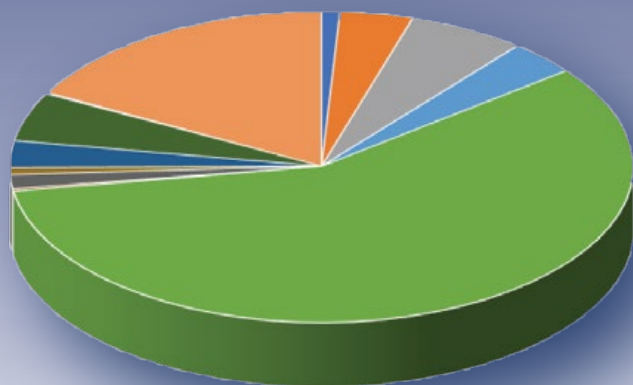

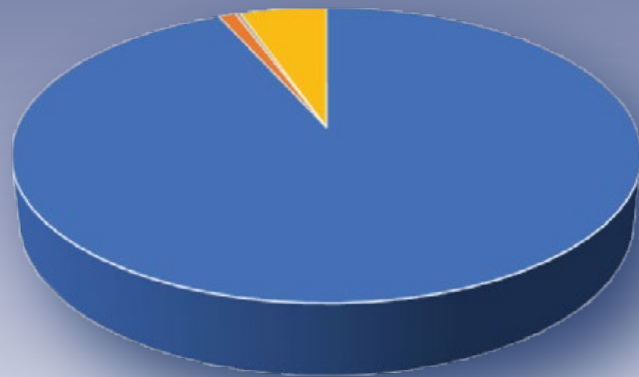

\*Centaur Asset Management has been mandated to invest monies on behalf of the Foundation with a view to long term out-performance (of JSE listed equities) and an annual liquidity need of 4% - 6% of the gross capital under management, at the beginning of each year.



## FUNDS AND PROGRAMMES

The Foundation can receive both restricted and unrestricted donations. Unrestricted donations are allocated and utilised at the discretion of the Trustees for the purposes that conform to the mission of the School; this provides important flexibility to the Trustees and the School Executive. Restricted donations meet the specific aims of donors who may wish to direct their giving at other projects or objectives.

A taxpayer making a bona fide donation in cash or kind to the Foundation (an organisation approved in terms of Section 18A of the Income Tax Act 58 of 1962) is entitled to a deduction from their taxable income of the amount donated and the Foundation issues the donor with a tax certificate entitling the donor to claim the donated amount as a deduction (up to 10% of taxable income).

The funds indicated below are the established Foundation funds.

### ***Endowment Fund***

The Endowment Fund is an investment Fund set up to provide long-term



sustainable support to St David's Marist Inanda, as well as annual liquidity to support Foundation Bursaries and projects if required.

### ***Bursary Funds***

#### **Father Bernard Brewer SJ Bursary**

The Father Bernard Brewer SJ Bursary Fund enables St David's to support deserving boys with potential from previously disadvantaged backgrounds.

#### **Mizpah Bursary Fund**

The Mizpah Bursary Fund ('Mizpah' is a Biblical term meaning 'words of blessing, protection and inspiration') was founded in August 2017 by a Bursary Recipient who matriculated at the end of 2017. His wish in founding the Bursary, with an initial R1 000 that he had raised through his own efforts, is that future boys in need will be able to have the same opportunities as he enjoyed at St David's.

#### **Willy & Dorothy Castle Extramural Bursary**

Bursary, named in honour of Willy Castle, and his mother Dorothy Castle, is awarded to boys who show promise in the areas of sport or cultural whilst being able to maintain the required academic standard.

### Tertiary Education Bursary Fund

The Tertiary Education Bursary fund provides tertiary bursary support (following the approval of an official approach) for St David's past pupils wishing to pursue a teaching qualification or funding donated by specific donors towards their St David's bursary recipient's tertiary education requirements.

### Old Boys' Bursary Fund

The St David's Marist Old Boys' Bursary is a grant that is awarded by the Marist Old Boys' Association either to the son of an Alumnus or to a candidate identified by the Association.

### Staff Giving Fund

The Staff Giving Fund currently assists numerous learners with support for uniforms, books, the payment of school tours, and other incidental costs.

### *The Business in Education B-BBEE Bursary Fund Initiative*

#### **'Growing tomorrow's business leaders together'**

The Business in Education Fund was created to enable corporate and business enterprises to partner with the Foundation in realising measurable and quality education intervention programmes through full bursaries to St David's for identified learners from historically disadvantaged backgrounds. The introduction of the



Revised Broad-Based Black Empowerment Codes of Good Practice created various opportunities through which corporate and business funders can benefit when making contributions to the St David's Marist Foundation.

The Foundation has both the structure and the strategic approach through which to successfully engage enterprise in this arena and was specifically designed to allow for the separate accounting and reporting process required by the B-BBEE Codes, to give corporate funders maximum scoring benefit in the SED (Socio-economic Development) and SD (Skills Development) categories

### *Family Funds*

A Family Scholarship Fund can be set up in memory of a loved one, in celebration of the blessings you have received as a family, as a family legacy or just to make the difference in the life of a boy who would otherwise not have had the opportunity to attend St David's, but without the administrative burden or fiduciary responsibilities to you

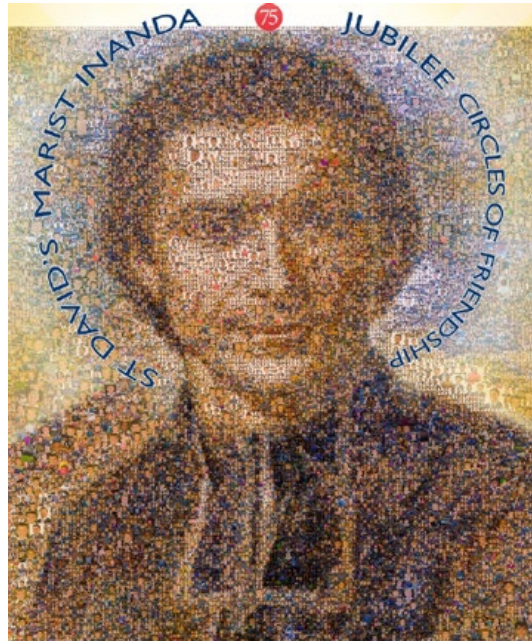

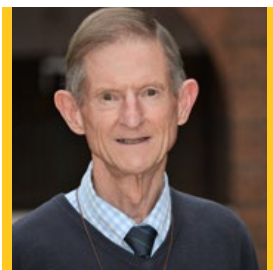

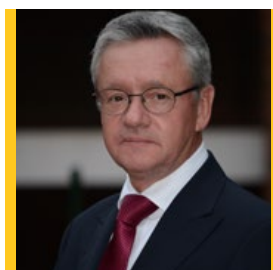
### *Honorary Patron –* **Brother Jude Pieterse**

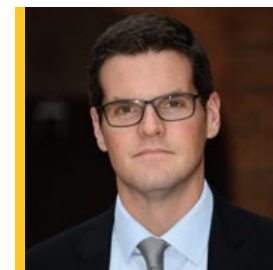
### **Andy Hall** *(Outgoing Chairman)*

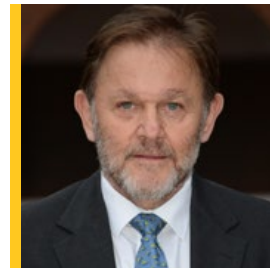
### Brother Fortune Chakasara

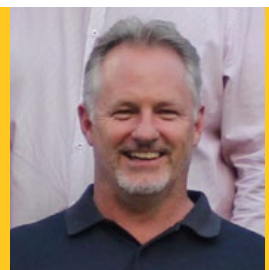

### Darrell Caister

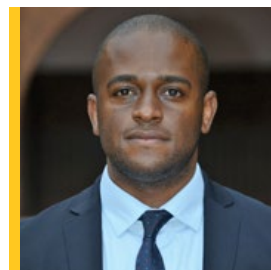
Darrell is an Old Boy of St David's and was the 1986 Head Boy. Darrell previously served as

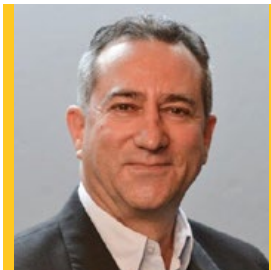

*(ex officio - Chairman of the Board of Governors)*

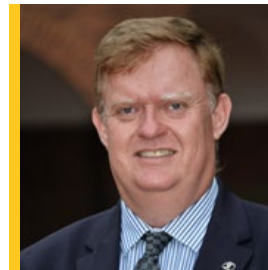

*(Head: Advancement)*

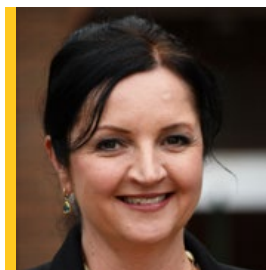
