



This report covers the 2020 Financial Year and includes extracts from the audited Annual Financial Statements for the year ended 31 December 2020.

It is my pleasure to introduce the St David's Marist Foundation's 2020 Annual Report to you. To provide you with assurance on how the Trustees collectively manage the Foundation's income and capital, I begin my report with a reminder of the core objectives of the Foundation:

- The main object is to receive donations from third parties for the purpose of:
 - o applying such funds for education and development at the School; and
 - o the provision of support services to, or the promotion of the common interests of the School.
- Furthermore, the Foundation may provide funding and support services in the furtherance of the

main object of the Foundation for other purposes such as:

- o the provision of related and associated education and development courses in relation to academic enrichment, academic support, supplementary tuition or outreach programmes for the disadvantaged, and the provision of scholarships, bursaries and awards for study programmes, research and teaching;
- o to erect or contribute to the cost of erection of any buildings required for or incidental to the promotion of the purpose and objectives of the Foundation:
- o to supplement the salaries of any existing or future teachers at the School: and
- o to initiate and participate in fundraising ventures to raise funds to promote the objects of the Foundation.



Other key subsets of the objects include:

- raising the capital required to support bursary and development programmes through the income derived from such capital; and
- promoting meaningful transformation within the School.

Central to these objects is ensuring that St David's boys receive a balanced education, grounded in the Marist philosophy, and to maintain the standards and promote the diversity required in South Africa.

The Foundation's cumulative efforts over a fourteen-year period to date are presented below:

- Donations received: R25.4 million (2019: R23.3 million);
- Investment income, after expenses: R10 million (2019: R8.5 million);
- Realised and unrealised gains on

- investments: R13.2 million (2019: R12.4 million): and
- Awards made: R18.4 million (2019: R15.1 million).
- Net capital as at 31 December 2020: R30.3 million (2019: R28.7 million) and the Foundation's total income since inception: R51.5 million (2019: R46.6 million).



The year under review

As Trustees we are deeply aware of our responsibility to manage the funds received by the Foundation in a judicious and prudent manner, taking into account the Foundation's commitment to sustainably support current bursary recipients and if possible grow awards over time, as well as our duty of care to donors through the manner in which we manage their contributions.

Our goal remains to realise capital growth in excess of inflation, with a view to making annual awards of between 4% - 6% of opening capital to qualifying programmes and bursary recipients. This is in addition to donor-specific bursary funding which is received annually and goes directly to the bursary costs of the applicable recipients each year.



Through the Foundation's investments in the Centaur BCI Flexible Fund (Centaur Fund) and the Coronation Strategic Income Fund (Coronation Fund) the underlying asset allocation comprises a diversified spread in South African listed equities, preference shares, offshore investments, cash, bonds and property. Approximately 50% of the Foundation's funds are invested in the Centaur Fund, 40% in the Coronation Fund and the balance in interest-bearing money market deposits.

As a result of the Covid-19 pandemic, 2020 proved to be one of the most challenging year's in the Foundation's and School's history, affecting the way in which the School's student body and staff conducted their learning, and the ability of the Foundation's Trustee's to interact with each other, our donors and bursary recipients. Nonetheless, I'm proud to reflect on the innovation and resilience exhibited by the School and Foundation to ensure productive and meaningful activity.

At the start of the lockdown in March 2020, St David's Head Prefect, Nqubeko Mthabela quoted novelist James Lane Allen in an online address to the boys of St David's Marist Inanda, "Adversity does not build character, it reveals it." It was a year that no one could have foreseen, but one during which our donors' hearts and sense of family spirit came even more to the fore.



In addition, in April 2020, in response to the Covid-19 pandemic, and the devastating effect it was having on so many lives and livelihoods within the St David's community, the St David's Marist Foundation Trustees approved extraordinary grant funding of R200 000 to a St David's Benevolent Fund, for the School to utilise at its discretion. This funding was utilised in support of a three-month Winter Relief grant made to all the bursary recipients and their families to ensure that their basic needs were taken care of during the height of the lockdown, including food and warm clothing, plus ensuring online connectivity for the bursary recipients so that they could continue their St David's schooling with as little disruption as possible.

We were extremely proud to have two Foundation-funded bursary recipients matriculate at the end of 2020, in an unstable and unpredictable year. Both young men achieved excellent results, with one of the bursary recipients being placed in the Top 1% of IEB (Independent Examinations Board) Business Studies candidates. In addition, these young men truly showed themselves to be Marist men receiving awards for academics, music and service during their final year.



The Mizpah Bursary Fund, founded by one of the 2017 Matric bursary recipients to ensure that future boys in need will be able to receive the same opportunities he did at St David's, with R1 000 he had raised through his own efforts, had through donations and investment income, grown to R83 086 (2019: R76 228) by the end of 2020.

In reviewing the Foundation's activities in 2020 the following is worth mentioning:

- The Foundation's fund-raising efforts raised a total of R2 633 736 (2019: R2 751 915).
 These included donor-specific awards of R1 679 885.
- The gain from investment activities before interest and dividends, net of expenses, amounted to R777 863 (2019: R1 424 724).
 The total growth in the investment portfolio of the Foundation of 8% (2019: 11%), being capital growth plus interest and dividends, was made in spite of the battering the

- financial markets took in Q2 of 2020, due to the impact of the pandemic.
- Awards paid to the School amounted to R3 226 829 (2019: R2 807 669) an increase of 15%. Excluding donor-specific awards the award made by the Foundation comprised 4.7% (2019: 4.8%) of the Foundation's capital at the beginning of 2020. Including donor-specific awards the award made by the Foundation comprised 10.9% (2019: 10.2%) of the capital at the beginning of the year.
- 23 young men were supported on bursaries in 2020 (2019: 22) and of these bursaries 4 included boarding at St David's.
- The Foundation's capital, after expenses and awards to the school, increased by 5.3% to R30 302 100 (2019: R28 771 438) as at 31 December 2020.

The Foundation's operational expenditure for 2020 amounted to R91,111, all of which was utilised in support of fund-raising development and initiatives.





The School continues to cover the majority of the operational expenses of the Foundation office and we are grateful for the support. In time, the Foundation is resolved to becoming sustainable, without financial support from the School. Reasons for this include the intention to remove this particular cost burden from the School and, more importantly, that certain overseas organisations we approach for funding require operational costs to be included in any funding proposal as they recognise that an organisation of the Foundation's nature should be sustainable on an independent basis. It remains our objective that 100% of donor funding will always go to the purposes intended, with operational costs being covered only by specifically-allocated portions of grants, or from interest and dividend income.

Finally, the Foundation continues to work closely with the Old Boys' Association in supporting their specific donor funds, managing their invested donor funds and growing the Alumni community.



The goal of the Foundation is to increase the number of boys who are fully supported on bursaries at St David's, within our self-imposed constraints and taking into account the turbulent times being experienced in financial markets, and cognisant of the educational divide that has been even more exacerbated by the Covid-19 pandemic.

During 2020, 23 young men, who would otherwise not have had the benefit of a St David's education were supported by the Foundation.

The St David's Marist Foundation Office's strategy since 2015 has been to adopt a multi-facetted plan and approach to the concepts of giving and philanthropy. There are short, medium and long-term programmes and strategies in place, and these continue to gain traction as the awareness of the Foundation increases.

For the forthcoming year (2021), the Foundation has resolved to award an amount of R3 071 107 (2020: R2 754 900) to the School, specifically for bursary awards. (The balance of the 2020 award (R496 929) comprised funding to the Benevolent Fund and specific donor funding to tertiary bursary support - a total 2020 award amount of R3 226 829). It is evident that the huge generosity of our donors and the tireless work of our Foundation Manager is making a material impact in helping to develop some of our society's future leaders.



The Foundation could not exist without the support of our generous donors, a number of whom have shown amazing long-term commitment to our objectives, and year after year continue to recognise the difference they are able to make in giving the precious gift of a Marist education to under-privileged boys. We recognise that every donor's contribution is made in today's immensely challenging economic circumstances, with the added impact of the entirely new world that the Covid-19 global pandemic has presented us with, and balanced against the needs of many other worthy causes. I extend very deep and humble gratitude on behalf of the Trustees and the School for all the pledges, donations, bequests and other contributions made by donors over the last year.

I must make special mention of the commitment of Lara Klement, the School's Head of Advancement, and Fiona Budd, our Foundation Manager. Their selfless efforts, innovation and persistence are reflected in the donations received in 2020 of almost

R2.7 million - a magnificent achievement. I also thank my fellow Trustees. It is a privilege to serve alongside you all.

In particular, I thank Mike Greeff, one of our founding Trustees, who stepped



down in mid-2020. His years of selfless Marist service and contribution, since the inception of the Foundation, leave a legacy that we are proud to continue to build on, and a tribute to Mike follows on

page 11. During 2020 we were delighted to welcome on board two new Trustees -Br Fortune Chakasara, Marist Provincial of South Africa, and Ms Fiona Budd, in an exofficio capacity as Foundation Manager of the St David's Marist Foundation, Br Jude Pieterse stepped down as a Trustee during 2020 but remains as the Honorary Patron of the Foundation, and Br Fortune takes up Br Jude's place in representing the Marist Brothers on the Board of Trustees.

We thank the Foundation's accountants -Sergio and Vannessa Maraschin, and Adri du Plessis of Accvantage Solutions for the seamless and professional way in which they manage this important function for the Foundation.

Finally, to the School's Executive and Board of Governors, the Marist Schools' Council. the Advancement Office, the Marist Old Boys' Association and the St David's Staff, thank you for your continued support.

As is often the case when I am looking for inspiration for a report or article, a piece of writing from the Marist Brothers (current or past) comes across my desk and provides not only the inspiration, but often the exact words needed to convey my thoughts.

Whilst these words are needed 'for the moment', they also often serve to validate the work we are doing and are a reminder of our vision and mission in Marist schools.

I therefore share with you parts of the recent message from Br. Ernesto Sánchez Barba, Superior General of the Marist Institute and some personal reflections thereafter.


WITH MARCELLIN, TAKE THE LONG VIEW...

A year ago, we reflected on St. Marcellin's confidence, boldness and fraternity as some of the basic elements that spurred him to keep

moving ahead, to not be paralysed by fear and to not remain cosily in his comfort zone in the difficult times in which he found himself.

One year on, we are still living in a context of uncertainty and instability around the world. The Covid-19 pandemic has wreaked havoc in many parts of the globe. Although it seems that some matters are being brought under control, we find ourselves faced with other social, political and economic problems; they may have been present before but have now surfaced due to the pandemic, or they have sprung up as emerging issues yet to be addressed, supported or resolved.

It has been a real blessing to witness the degree of solidarity shown during the pandemic: the risk-taking of so many in the health services and the generosity of those who have fearlessly reached out to the most needy and vulnerable. It is pleasing as well to see the human face of solidarity in evidence in many parts of the Institute, within, between and beyond our communities, our apostolic



works, Provinces and Districts. In one way or another, we have felt more like a global family, despite the physical separation and the limitations that exist today in regard to travelling and meeting one other.

At the same time, many situations have become evident in the world where an attitude of self-protection and looking out for one's own predominates, where people easily forget and leave aside those who are suffering the most. Relationships have proved a challenge in both communities and families, sometimes resulting in psychological barriers or hurts that could be considered worse than the virus itself. Many have experienced anxiety and profound grief related to the serious illness and the loss of loved ones. A good number of people have lost their jobs and new pockets of poverty are emerging. The contrast between countries or states that are well-resourced and those with more limited means in the fields of health and economic activity is becoming more obvious.

Marcellin took the long view ...

As I reflect on these situations, the image of Marcellin as a man of vision comes to my mind. He was capable of envisioning a horizon far beyond his own confines and limitations. Several episodes in his life show us clearly that he did not lose heart when



difficulties arose. We can even say that the difficulties themselves strengthened his capacity for resilience....

... we know of situations in his life which were not easy but in which he was able to take the long view: periods when vocations faltered; frequent criticisms, even from clerics close to him; difficulties in paying off the debts he was responsible for; some crises within the community of brothers; difficulties in relation to some schools; the times he was gravely ill and vulnerable; the long wait to obtain authorisation from the Institute; periods of social, political, religious crisis; etc. In the face of all these challenges, Marcellin was able to keep moving forward, to cut into the rock and to build. His faith and his deep conviction that this work was God's work. Mary's work, made him always hopeful. He knew how to walk alongside his brothers, listening to them, encouraging them and also confronting them when necessary.

Taking the long view ourselves


Along with Champagnat's founding intuition that gave birth to our Institute, throughout our history we have had remarkable



examples of people of vision able to face a variety of crises, even persecution, people who took the long view. Today, brothers and lay people, we want to continue to journey together as we seek to keep Marcellin's dream alive in our different settings. We are invited to be people of vision. It is time to develop more creativity and to innovate.

In a few months, it will be four years since we received the calls of the XXII General Chapter: to journey together as a global charismatic family, to be beacons of hope, the face and hands of God's tender mercy, bridge-builders, journeying with children and young people living on the margins of life and responding boldly to emerging needs... These prophetic calls retain great relevance for us today...

Beacons of hope light up our world and let us see into the distance. At the same time, the light they cast allows them to be seen from afar and to generate optimism... We cannot remain paralysed by the situations of uncertainty and complexity that we live in,




but rather we are being invited to look and reach beyond our own securities...

As bridge-builders, we take the long view when it comes to boundaries and chasms: bridges that open a path to deeper, more personal relationships with those we live and work with on a daily basis and with those we serve in our ministry; bridges that span the gulfs and cross the borders associated with intercultural and international differences; bridges that enable communication and solidarity support, the sharing of resources; bridges between different generations... We are called to make plain the prophecy of mercy and brotherhood, being the face and hands of God's tender mercy.

When facing new peripheries and emerging situations, we must try to learn more about them and respond boldly. In taking the long view, we have to move beyond a focus on our own comfort and security to become more supportive of others. Pope Francis, in his recent Encyclical Fratelli Tutti, refers to the value of solidarity in this way:







At a time when everything seems to disintegrate and lose consistency, it is good for us to appeal to the "solidity" born of the consciousness that we are responsible for the fragility of others as we strive to build a common future. Solidarity finds concrete expression in service, which can take a variety of forms in an effort to care for others. And service in great part means "caring for vulnerability, for the vulnerable members of our families, our society, our people". In offering such service, individuals learn to "set aside their own wishes and desires. their pursuit of power, before the concrete gaze of those who are most vulnerable... Service always looks to their faces, touches their flesh, senses their closeness and even, in some cases, 'suffers' that closeness and tries to help them. Service is never ideological, for we do not serve ideas, we serve people". (n. 115).

...Like Marcellin, let us be encouraged to take the long view, and seek to respond with the same enthusiasm and intuition that he responded with in his day. We can count on the same enlightenment and strength that he had from Mary, our Good Mother, who continues to inspire and accompany us on this journey..."

We remain indebted to all who have travelled this road with us and hope that those that share our vision will commit to the 'long view' and continue on this exciting journey with us!



As we all know, 2020 was a year like no other – as with every other area of St David's, lockdown took the St David's Marist Foundation online.

Whilst there were many challenges and we could not hold some of our traditional on-campus events and initiatives, an online community and world created new opportunities as well as a chance to re-look 'business as usual'.

2020 and #StDavidsOnline (Foundation Bursary Fund Recipients)

During 2020, thanks to the generosity of our donors, the Foundation was able to provide funding for 19 St David's College bursaries, plus manage the donor funding for a further 4 tertiary bursaries. The almost overnight transition to St David's online on 18 March required quick assessment and consideration of what this meant for the St David's bursary recipients who did



not have connectivity resources at home. The bursary recipients (both Foundation-funded and School-funded) were, within a couple of days, set up with their own wifi routers and data to ensure that there was as little disruption as possible to the academic year. There was an amazing team effort by the St David's staff who work in support of the bursary programme, in areas such as Finance, IT, Wellness and Academic Enrichment, to ensure that the bursary recipients and their families remained fully connected and taken care of, also in terms of the broader impact of the pandemic and lockdown. The

St David's Marist Foundation Trustees approved a Benevolent Fund grant to St David's which included a three-month Winter Relief grant made to all the bursary recipients and their families to ensure that their basic needs were taken care of during the height of the Lockdown, which was also one of the coldest winters in Johannesburg in recent years.

2020 was a year in which we were all reminded about what is truly important. It was heartwarming to experience the proactive care and thoughtfulness of St David's families who made contact to donate funds towards assisting Estate and Support Services staff and contract coaching staff during the off campus lockdown period. Our existing St David's donors not only continued their support to the Foundation bursary, development and benevolent funds, but in many cases increased their support, with several new donors coming on board. The Foundation had received donations totaling R2 633 736 by the end of 2020, and had made a 2020




total award of R3 226 829 to the School in support of bursary funding, development funding and benevolent fund support.

2020 also provided an opportunity to explore new ways of challenging, connecting and contributing through the Foundation.

St David's Staff Champagnat Day Charity Marathon Challenge 2020 (Saturday 6 June 2020)


On Saturday 6 June, twenty-four St David's Staff, on the initiation of and led by Coach Kenneth Malope, ran individual distances of up to 21kms as part of the inaugural Champagnat Day St David's Staff Charity Marathon Challenge, to raise funds to support those of the St David's community in need as a result of the pandemic. Eight staff members ran 21kms each – staff ran (or walked) their own routes within and around the St David's campus and in their home neighbourhoods. The Staff Team

raised R21 350 and it is planned that the Champagnat Day Marathon will become an annual event at St David's. The Team involved in the Champagnat Day Marathon, headed by Clive Venter and Carole Hatfield, took Kenneths's initiative forward for the remainder of 2020, with a St David's Community 1st Weekend individual run/









walk/cycle or golf round, in support of the Staff Giving Fund and Community Development Fund – an additional R10 660 was raised in this way through the six events that took place, including a Mandela Day weekend run. Mr Brad Ireland clocked this impressive Mandela Day route and run on Strava! (See lower left image). Our sincere thanks to all staff, parents and boys who took part in the 1st Weekend events.

It was therefore committed that the 2020 Montagne Day pledge funds would go to supporting students in the township of Alexandra

through a St David's partner organisation there. Montagne Day donations of R20 000 were received and were donated to the Alexandra Education Committee.

The Term 3 Foundation Philanthropy Forum focused on Montagne Day 2020 and the Montagne Day Pledge Campaign and included interviews with Fr Brian Mhlanga, Mrs Cherie Smith and Mr Sheldon Rose-Reddiar.





Christmas Giving 2020

Christmas Giving, an annual campaign at St David's since 2014, was again very generously supported by our St David's families and community in giving the gift of kindness to those within the St David's community who have been particularly impacted by the Covid-19 pandemic and lockdown. privileged to experience the hearts, support, Marist ethos and values of our St David's community expressed in the most beautiful ways.





*Centaur Asset Management has been mandated to invest monies on behalf of the Foundation with a view to long term out-performance (of JSE listed equities) and an annual liquidity need of 4% - 6% of the gross capital under management, at the beginning of each year.



The Foundation can receive both restricted and unrestricted donations. Unrestricted donations are allocated and utilised at the discretion of the Trustees for the purposes that conform to the mission of the School; this provides important flexibility to the Trustees and the School Executive. Restricted donations meet the specific aims of donors who may wish to direct their giving at other projects or objectives.

A taxpayer making a bona fide donation in cash or kind to the Foundation (an organisation approved in terms of Section 18A of the Income Tax Act 58 of 1962) is entitled to a deduction from their taxable income of the amount donated and the Foundation issues the donor with a tax certificate entitling the donor to claim the donated amount as a deduction (up to 10% of taxable income).

The funds indicated below are the established Foundation funds – in addition, in April 2020, in response to the Covid-19 pandemic, and the devastating



effect it was having on so many lives and livelihoods with the St David's community, the St David's Marist Foundation Trustees approved grant funding to a **St David's Benevolent Fund**, for St David's Marist Inanda to utilise at their discretion.

Endowment Fund

The Endowment Fund is an investment
Fund set up to provide long-term
sustainable support to St David's Marist
Inanda, as well as annual liquidity to
support Foundation Bursaries and projects.

Bursary Funds

Father Bernard Brewer S. J Bursary

The Father Bernard Brewer S. J Bursary enables St David's to support deserving boys with potential from previously disadvantaged backgrounds.

Mizpah Bursary Fund

The Mizpah Bursary Fund ('Mizpah' is a Biblical term meaning 'words of blessing, protection and inspiration') was founded



in August 2017 by a Bursary Recipient who matriculated at the end of 2017. His wish in founding the Bursary, with an initial R1 000 that he had raised through his own efforts, is that future boys in need will be able to have the same opportunities as he enjoyed at St David's.

Willy & Dorothy Castle Extramural Bursary

The Willy & Dorothy Castle Extramural Bursary, named in honour of Willy Castle, and his mother Dorothy Castle, is awarded to boys who show promise in the areas of sport or cultural whilst being able to maintain the required academic standard.

Tertiary Education Bursary Fund

The Tertiary Education Bursary fund provides tertiary bursary support (following the approval of an official approach) for St David's past pupils wishing to pursue a teaching qualification or funding donated by specific donors towards their St David's bursary recipient's tertiary education requirements.

Old Boys' Bursary Fund

The St David's Marist Old Boys' Bursary is a grant that is awarded by the Marist Old Boys' Association either to the son of an Alumnus or to a candidate identified by the Association.

Staff Giving Fund

The Staff Giving Fund currently assists numerous learners with support for uniforms, books, the payment of school tours, and other incidental costs.



The Business in Education B-BBEE Bursary Fund Initiative

'Growing tomorrow's business leaders together'

The Business in Education Fund was created to enable corporate and business enterprises to partner with the Foundation in realising measurable and quality education intervention programmes through full bursaries to St David's for identified learners from historically disadvantaged backgrounds. The introduction of the Revised Broad-Based Black Empowerment Codes of Good Practice created various opportunities through which corporate and business funders can benefit when making contributions to the St David's Marist Foundation.

The Foundation has both the structure and the strategic approach through which to successfully engage enterprise in this



arena and was specifically designed to allow for the separate accounting and reporting process required by the B-BBEE Codes, to give corporate funders maximum scoring benefit in the SED (Socio-economic Development) and SD (Skills Development) categories.

Family Funds

Contact us to discuss establishing a Family Fund or Scholarship under the banner of the St David's Marist Foundation. A Family Fund or Scholarship aims to ensure that a boy (or boys) attend St David's in your family name in perpetuity, i.e. a new boy is awarded a scholarship in your name upon the Matriculation of the previous beneficiary, or alternatively you can ask that your Fund is utilised according to the Trustees' discretion for the benefit of St David's Marist Inanda.

A Family Scholarship Fund can be set up in memory of a loved one, in celebration of the blessings you have received as a family, as a family legacy or just to make the difference in the life of a boy who would otherwise not have had the opportunity to attend St David's, but without the administrative burden or fiduciary responsibilities to you involved in establishing an independent Trust.

Project, Facilities & Development Funds

The Foundation seeks to provide St David's with funding support for development of the School campus facilities to enhance and support curriculum activities and



enable students to experience an education at the highest level, through the following five funds.

Capital Development

Provides funding support for the development of the School campus facilities to enhance and support curriculum and extra-curriculum activities and enable students to experience an education at the highest level.

Leadership Development

Provides funding support for programmes and projects to assist in developing the leadership potential and ability of students to the highest level.





Cultural Development

Provides funding support for programmes and projects to assist in developing and growing the cultural activity potential and ability of students to the highest level.

Sports Development

Provides funding support for programmes and projects to assist in developing and growing the sporting potential and ability of students to the highest level.

Community Development

St David's Marist Inanda is currently involved in over twenty-four community involvement and service projects across the Preparatory and High School. Programmes include educational support and enrichment, sports development, feeding programmes, project visits and financial and resource donations. The projects are all very hands-on with St David's boys expected to actively initiate, lead, participate in and commit to programmes and projects. Each year a

major project is undertaken by the Grade 11 'Hands of Champagnat' group. The School's project selections are guided by the Key Strategic Drivers (KSDs) that underpin all activities that take place at St David's, and the St David's Marist Foundation assists where required with guidance, support and donor funding administration and channelling.

Maristonian Project Fund

The St David's Marist Foundation administers the receipt of funds and donations towards the St David's Old Boys' Association's Maristonian Project – a project which includes the building of a home base for the Old Boys' Association.

The Marist Legacy (Bequests)

This Fund offers donors the opportunity to leave a Lasting Marist Legacy through a Bequest to the St David's Marist Foundation. The impact of a bequest reaches far into the future and beyond a lifetime.



Montagne Day, and the Montagne Day Pledge campaign, was launched at St David's Marist Inanda in 2016, in remembrance of St Marcellin Champagnat's meeting with the dying young Jean-Baptiste Montagne on 28 October 1816 a meeting which inspired his vocation to found the Marist teaching order. In the spirit of the 75th Jubilee and the Marist value of 'Love of Work', each St David's boy was encouraged to raise, through his own efforts or acts of service, R75 to contribute to the Jubilee Circles of Friendship initiative, in support of a Bursary for a young boy in need. These donations formed the start of each year group's own Jubilee Circles of Friendship as per the Matric Years that they will eventually become, for example, those boys who were in Grade 6 in 2020 will be the Matric Class of 2026.

Montagne Day takes place each year at St David's on or around 28 October, with the aim of encouraging the St David's boys to become the next generation of young philanthropists. Since 2016 the annual pledges have raised just over R170 000.

In previous years Montagne Day Pledge donations were in support of the Foundation Fr Bernard Brewer Bursary Fund, in support of further bursaries to St David's. However in 2020 the St David's boys, in keeping with the theme of 'Homes of Light' and 'Family Spirit', were asked to think about how many children in South Africa were experiencing a lost school year due to not having had the benefit or access to online schooling that the St David's boys were fortunate to be able to have during Lockdown. It was therefore committed that the 2020 Montagne Day pledge funds would go to supporting students in the township of Alexandra through a St David's partner organisation there. Montagne Day donations of R20 000 were received and were donated to the Alexandra Education Committee.

Mike joined St David's as Headmaster of the High School in January 2014.




